The above facilities have re-applied for National Pollutant Discharge Elimination System (NPDES) permits in accordance with the provisions of Chapter 90.48 Revised Code of Washington (RCW), Chapter 173-220 Washington Administrative Code (WAC), and the Federal Clean Water Act.

Liberty Lake Sewer and Water District owns and operates a biological nutrient removal, membrane filtration treatment facility located in Spokane County. The wastewater facility has a design flow of 2.0 million gallons per day (mgd). LLSWD discharges UV-disinfected effluent to the Spokane River approximately 3.5 miles downstream from the Washington/Idaho border. The system collects and treats the sanitary wastewater from approximately 4,018 ERUs (Equivalent Residential Units) as well as commercial and light industrial dischargers.

Spokane County Regional Water Reclamation Facility owns and operates a municipal wastewater treatment facility in Spokane County that provides advanced treatment and discharges treated, disinfected and dechlorinated effluent wastewater to the Spokane River with a monthly average design flow of 18.5 million gallons per day (gpd).

Following treatment, wastewater must meet the requirements of the Washington State Water Pollution Control Act and applicable regulations in order for a permit to be issued.

Following evaluation of the applications and other available information, Ecology has drafted these permits to allow the discharge of wastewater with the appropriate permit limits and conditions. A tentative determination has been made on the effluent limitations and special permit conditions that will prevent and control pollution. A final determination will not be made until all timely comments received in response to this notice have been evaluated.
