Dear Barb Brown:

This letter is to inform you that your facility was out of compliance with the conditions in your industrial wastewater discharge permit as listed in Table 1.

*The pH limit changed from 11.0 to 10.0 during the permit reissuance effective November 1, 2021. The limit was changed to reflect the City of Marysville local limit for pH.

Non-compliance notifications are required by your permit. Ecology provided technical assistance via email on 2/23/22 about providing non-compliance notifications on DMRs when an effluent violation occurs. Starting on the January 2022 monthly DMR, you provided non-compliance notifications for pH limit exceedances, except for the March 2022 DMR for the pH violation that occurred on 3/29/22. **You must submit this notice immediately** for any violations that have occurred. You may submit these past non-compliance notifications via email. You may refer to **permit section S3.F.** for more information about what must be included in a written notice of non-compliance. Moving forward, the written notice of non-compliance should be attached to every DMR submission that contains violations.


The Department of Ecology (Ecology) uses the DMR to evaluate compliance with permit requirements. If you fail to comply with the conditions of your permit, Ecology may take formal administrative enforcement action, including issuing orders and penalties. Ecology's enforcement authority for state waste discharge permits is governed by Chapter 173-216 of the Washington Administrative Code (WAC).
