State Waste Discharge permit ST0501285 is due to expire on November 30, 2023 and requires an application for its renewal. To allow Ecology sufficient time to develop Ancient Lake Wine Company's permit, a completed application must be received by our office **on or before November 30, 2022**. A principal executive officer must sign the application (WAC 173-216-070).

Permit Fees

Fees paid by permit holders support the wastewater permit program (RCW 90.48.465). Ecology regulation (Chapter 173-224 WAC) establishes annual permit fees to recover costs associated with issuing and managing wastewater discharge permits. Ecology will continue to collect annual permit fees unless the permit is formally cancelled. Please call 1-800-633-6193 (option 2) with questions about permit fees.
