Re: **WARNING LETTER:** State Waste Discharge Permit Number ST0007332, National Food Corp

Dear Mr. Gemperle:

This letter is to inform you that your facility was out of compliance with the conditions in your industrial wastewater discharge permit as listed in Table 1.

Non-compliance notifications are required by your permit. You have explained the cause of the numeric effluent violations (Table 1) on your discharge monitoring reports (DMRs). However, there is no explanation for the missing pH Daily Max values on the July 2022 DMR. You must correct the DMR or provide an explanation to Ecology for the daily sampling frequency violation (Table 2).

Your facility has a pattern of BOD₅ and TSS violations. We recommend that you (1) identify the source and take action to prevent future violations and (2) improve training for new employees prior to conducting laboratory analysis of samples.

The Department of Ecology (Ecology) uses the DMR as the principal tool to evaluate compliance with permit requirements. Ecology places great importance on timely submittal of complete and accurate DMRs. If you fail to comply with the conditions of your permit, Ecology may take formal administrative enforcement action, including issuing orders and penalties. Ecology's enforcement authority for state waste discharge permits is governed by Chapter 173-216 of the Washington Administrative Code (WAC).
