Thank you for your Sand and Gravel General Permit Change Request Form to transfer permit coverage with a name change. This transfer is due to the sale of Ferguson Concrete & Excavation facility located at 4597 Road 13.5, Royal City, WA 99356. This letter confirms the name change to Royal Premix Concrete LLC and transfer of coverage of Permit No. WAG507005 from Mark Ferguson to Brandon Jenks. Brandon Jenks has agreed to assume all responsibility, coverage, and liability of Permit No. WAG507005 as of November 10, 2022.

This transfer shall not be valid if there is or will be any significant change from the existing permit in facility operations, discharge volume, or discharge characteristics, as determined by the Department of Ecology.
