







NOTICE: ANNOUNCEMENT OF AVAILABILITY OF WASTEWATER DISCHARGE PERMIT TO THE CITY OF MARYSVILLE WASTEWATER TREATMENT PLANT

Permit No: ST0007332

Applicant: National Food NW LLC

Arlington, Snohomish County

has reapplied for a State Waste Discharge permit in accordance with the provisions of Chapter 90.48 Revised Code of Washington (RCW) and Chapter 173-216 Washington Administrative Code (WAC)

The wastewater, following treatment, must meet the requirements of the Washington State Water Pollution Control Act and applicable regulations for the permit to be issued. Following evaluation of the application and other available information, a draft permit has been developed which would authorize the discharge of wastewater from National Food NW LLC to the City of Marysville Wastewater Treatment Plant.

A tentative determination has been made on the effluent limitations and special permit conditions that will prevent and control pollution. A final determination will not be made until all timely comments received in response to this notice have been evaluated.
