Re: Application for Renewal of State Wastewater Discharge Permit

Permit No. ST0003974 was issued for the discharge of treated process wastewater from ZYK Enterprises wastewater treatment facility. This permit is due to expire on April 30, 2024 and requires an application for renewal. The completed application is to be received at this office by October 1, 2023.

The Ecology permit manager for your facility is Chris Martin. He has marked those sections of the application which need to be filled out based upon our understanding of your facility. If there have been significant changes to the facility or to the character of the wastewater, you may need to fill in additional sections. Look over all of the questions to see if there are some that are applicable even if they have not been marked. Please submit any additional information that you feel may help Ecology determine the impact of your discharge upon ground or surface waters.
