Dear Jeff Snyder:

The Washington Department of Ecology (Ecology) is required by law to collect fees from all wastewater and/or stormwater dischargers in the state that hold or apply for a discharge permit. The permit fee provisions of this law (RCW 90.48.465) are designed to fund Ecology's Administration of the federal and state water quality pollution control programs. As a result of this law, Ecology developed Chapter 173-224 of the Washington Administrative Code that establishes permit fees. This regulation was originally adopted in 1988 and is amended every two years.

This permit has a coverage date of May 18, 2017. This letter is meant give information on the annual fee and permit fee category for fiscal year 2016 (July 1, 2015 – June 30, 2016).

Fee Category: Concentrated Animal Feeding Operation
Subcategory: 200 to less than 400 animal units
2017 Fiscal Year Permit Fee: \$73.40 (prorated)
2018 Fiscal Year Permit Fee: \$633.00 (invoiced mid-September)

The fee for permits issued after July 1 has been prorated to the permit coverage date. An invoice is included.

Permit Fee Billing

Ecology mails invoices directly to the permit holder on record. Ecology will mail future invoices once per fiscal year during July for annual invoices. Ecology will mail semiannual invoices in July (first half of annual fee) and the following January (second half).

Nonpayment of Permit Fees

Permit holders who do not pay the assessed permit fee by the billing due date are considered delinquent. If payment is not received upon a specified date, the account may be turned over for collection. In addition, the collection agency adds a surcharge of 20 percent to the delinquent amount owed to cover the cost of the collection action. Delinquent municipal permit holders are notified by Ecology that if payment is not submitted within 45 days, Ecology may begin proceedings to terminate the permit for nonpayment of fees.

Permit Cancellation/Termination

Permit fees stop when the permit has been officially canceled or terminated by Ecology. Permit fees will continue until the permit is canceled regardless of when the permitted activity stopped. Ecology does not prorate fees at termination.

Permit Fee Appeal

You have a right to appeal this action. The appeal process is governed by chapter 43.21B RCW and chapter 371-08 WAC. "Date of receipt" is defined in RCW 43.21B.001(2).

To appeal, you must do the following within 30 days of the date of receipt of this letter:

- File your appeal and a copy of the permit cover page with the PCHB (see addresses below). Filing means actual receipt by the PCHB during regular business hours.
- Serve a copy of your appeal and the permit cover page on Ecology in paper form - by mail or in person (see addresses below). Email is not accepted.

You must also comply with other applicable requirements in Chapter 43.21B RCW and Chapter 371-08 WAC.
