Re: Flow Allowance Increases—State Waste Discharge Permit No. ST 6154

The Department of Ecology (Ecology) received a written notification of an anticipated bypass that had the potential to result in noncompliance with the State Waste Discharge Permit No. ST 6154 flow effluent limits. The written notification was received on August 2, 2023. The notification was submitted as required by the permit special condition S4.B.3. Jacek Anuszewski, who is a registered professional engineer at the Southwest Region Office, reviewed the notification and recommended approval assuming the following:

1. The flow allowance increases are related to a one-week maintenance activity, from September 3rd through September 10th.
2. The anticipated increase is maximum 430,000 gallons per day (gpd), or 25,700 gpd above the permitted 404,300 gpd during the specified above maintenance period.

The flow allowance increases, as described above, are hereby approved.

This office is to be notified immediately of any proposed changes or revisions to the approved flow allowance increases. Any such changes or revisions must be issued in the form of addenda, technical appendices, or supplemental reports to the original notification and must be approved in writing by Ecology.

Ecology's review and approval of this document is to assure compliance and consistency with the appropriate rules, regulations, guidelines, planning and design criteria, and/or other similar documents. Ecology's review shall not be construed as a quality control check or as approval with respect to the completeness, accuracy, or adequacy of this document.

This approval **does not** relieve the owner(s) of the proposed flow allowance increases from any other approvals as may be required by other governmental reviewing agencies. In addition, this approval **does not** relieve the owner or the owner's engineer from the responsibilities and liabilities that result from noncompliance with water pollution laws and regulations during the

upcoming 72-hour maintenance activity. Also, this approval **does not** relieve the owner or the owner's engineer from the responsibilities for the technical adequacy and/or accuracy of the contents of this document.
