**RE: Duty to Reapply for Western WA Phase II Municipal Stormwater General Permit –  
WAR045705**

Dear Chris Villa:

Our records indicate that your Municipal Separate Storm Sewer System (MS4) has coverage under the National Pollutant Discharge Elimination System (NPDES) Phase II Municipal Stormwater General Permit (Permit), issued by the Washington State Department of Ecology (Ecology). This permit expires July 31, 2024. General Condition G18, *Duty to Reapply*, requires that you submit a complete Duty to Reapply, Notice of Intent (NOI) form for permit renewal at least 180 days prior to the permit expiration date or by **February 2, 2024**.

Failure to submit a complete NOI 180 days before July 31, 2024 would constitute a violation of the permit, and would result in a gap in your NPDES permit coverage. If the issuance of the Final 2024 Permit is not reissued by July 1, 2024 (See WAC 173-226-220). A gap in permit coverage could lead to unauthorized discharges from your MS4, which would also violate 40 CFR 122 of the federal Clean Water Act and RCW 90.48 Washington State Water Pollution Control Act. As such, please submit your complete NOI no later than **February 2, 2024**.

**To Reapply Online**

The Washington State Department of Ecology (Ecology) uses SecureAccess Washington (SAW) to maintain security of your data. **Please follow these instructions to submit your NOI:**
