Dear Chris Vratil:

The State Waste Discharge Permit that was issued for your facility on March 30, 2020, is hereby modified for the following particulars:

- To allow submittal of the conceptual plans ([WAC 173-240-110\(5\)](#)) and extending the due date of the conceptual plans to May 1, 2024.

The enclosed permit is your official copy of the permit modification.

Appeal Process

You have the right to appeal this permit modification within 30 days upon receipt of this document. You are not able to appeal the entire permit. Pursuant to [Chapter 43.21B RCW](#), your appeal must be filed with the Pollution Control Hearings Board, and served on Ecology, within 30 days of the date of your receipt of this document.

If you choose to appeal this decision, your notice of appeal must contain:

- A copy of the permit you are appealing; and
- A copy of the application for the permit/modification.

Any appeal must contain the following in accordance with the rules of the Hearings Board:

- A. The appellant's name and address;
- B. The coverage date and number of the permit appealed;
- C. A description of the substance within the permit that is the subject of the appeal;
- D. A clear, separate, and concise statement of every error alleged to have been committed;
- E. A clear and concise statement of the facts which the requester relies on to sustain his or her statements of error; and

F. A statement setting forth the relief sought.
