**RE: Please Reapply for your Industrial Stormwater General Permit - WAR303006**

Dear Brandon Jensen:

Your facility is covered under Ecology's Industrial Stormwater General Permit (ISGP), which will expire on December 31, 2024. The ISGP requires you to reapply for permit coverage at least 180 days prior to the expiration date of the current permit (General Condition G8). You must reapply for the ISGP by **July 5, 2024, in order to maintain your permit coverage beyond the expiration date.**

If you fail to reapply for the ISGP, your permit coverage will terminate on December 31, 2024, when the current permit expires. If your permit is terminated and you discharge pollutants to waters of the State, you will violate the federal Clean Water Act and Chapter 90.48 RCW.

**To Reapply Online**

The Washington State Department of Ecology (Ecology) uses SecureAccess Washington (SAW) to maintain security of your data. To submit an electronic application through SAW, **please follow Ecology's ISGP renewal application instructions:**

However, you may **not make** changes to the permittee affiliation in this renewal process. Ecology is in the process of updating and reissuing the current ISGP.
