In 2023 staff performed outreach to some of the six identified sites on its Source Control Inventory list. Initial discussions were had with officials from Bellevue School District (operating two sites) and Bellevue Christian School (operating one site).

A site inspection was performed at Bellevue Christian School (BCS) where BCS staff accompanied Clyde Hill staff around the site. Effective practices were observed and staff made recommendations for minor improvements. BCS and Clyde Hill staff continued to coordinate on the recommendations and to share information post inspection. A summary table is provided below.
