Apologies for the hold up in my response to you! Since I don't work in the circulation department I had to do a little digging to find the answers you're looking for. While the Wenatchee World newspaper is based in and is distributed through Chelan county, I can confirm that we do also have a subscriber count and circulation within Douglas county. It looks like the notice in question was published twice on May 18 and May 25, and I can confirm that the publications this notice was featured in was distributed to our subscribers in Douglas county. We do however also handle the Douglas County Empire Press, and we run those legal notices through the [column.us](#) system as well, for future reference! When submitting a legal notice you should see the dropdown menu that allows you to select any of the three publications we handle - Wenatchee World, Douglas County Empire Press, and the Quincy Valley Post Register (now a once monthly publication).




