Effective October 1, 2024**

Dear Stanley Ryan or Scott Burleson:

Enclosed is your Modified National Pollutant Discharge Elimination System (NPDES) Waste Discharge Permit No. WA0052078 which has been issued in accordance with Chapter 90.48 RCW, as amended, and the Federal Water Pollution Control Act, as amended. This Modified NPDES Permit satisfies the requirements of both federal and state laws.

The modified permit is identical to the original permit, with the exception of the marked revised pages. Please have your staff replace the original pages of the permit with this revised pages for each copy of the permit made. The pages are clearly marked at the bottom "**THIS PAGE REVISED on October 1, 2024**".

The fact sheet amendment explains the regulatory and technical basis for the amended conditions contained in the permit.

A Public Notice of this modification was published in the Sunnyside Sun on March 20, 2024; **No comments were received**. Your permit modification became effective October 1, 2024.

Appeal Process

You have the right to appeal this permit within 30 days upon receipt of this document. Pursuant to chapter 43.21B RCW, your appeal must be filed with the Pollution Control Hearings Board, and served on the Department of Ecology, within 30 days of the date of your receipt of this document.

If you choose to appeal this action or decision, your notice of appeal must contain:

- (1) A copy of the permit you are appealing, and
- (2) A copy of the application for the permit.
