NOTICE: ANNOUNCEMENT OF AVAILABILITY OF DRAFT PERMIT MODIFICATION

Permit Number: WA000825

Applicant: Inland Empire Paper Company

Facility Address: 3320 North Argonne Road, Spokane, WA 99212

Inland Empire Paper Company has requested a National Pollutant Discharge Elimination System (NPDES) permit modification in accordance with the provisions of Chapter 90.48 Revised Code of Washington (RCW), Chapter 173-220 Washington Administrative Code (WAC), and the Federal Clean Water Act.

Inland Empire Paper Company is unable to meet its wasteload allocation specified in the NPDES permit issued in 2022 and has requested an extension to meet final water quality based effluent limits (WQBELS) for total phosphorus and five day carbonaceous biochemical oxygen demand (CBOD₅) based on the Spokane River and Lake Spokane dissolved oxygen total maximum daily load (DO TMDL). The seasonal average limits are applicable from February to October for total phosphorus and March through October for CBOD₅. Ecology is proposing to extend the compliance schedule through the end of the 2027 compliance season. The fact sheet amendment explains the compliance schedule and the request for an extension in more detail.

Ecology is issuing a draft amended permit and fact sheet amendment and is only accepting comments on the modified portions.

The wastewater, following treatment, must meet the requirements of the Washington State Water Pollution Control Act and applicable regulations for a permit to be issued. A final determination will not be made until all timely comments received in response to this notice have been evaluated.
