Dear Permittee:

The Washington State Department of Ecology (Ecology) has reviewed your Notice of Termination (NOT) of coverage under the Industrial Stormwater General Permit for the industrial site shown above. Based on the NOT, Ecology is terminating your coverage under the permit as of Nov 13, 2024.

Please ensure that you retain the Stormwater Pollution Prevention Plan (SWPPP) and copies of all of the application, inspection reports, and all other reports required by this permit for at least five years after the date of termination of the permit. These documents need to be available to Ecology and to the local government agencies with jurisdiction, upon request.

**Appeal of this Action**

You have a right to appeal this action. The appeal process is governed by chapter 43.21B RCW and chapter 371-08 WAC. "Date of receipt" is defined in RCW 43.21B.001(2).

To appeal, you must do the following within 30 days of the date of receipt of this letter:

- File your appeal and a copy of the permit cover page with the PCHB (see addresses below). Filing means actual receipt by the PCHB during regular business hours.
- Serve a copy of your appeal and the permit cover page on Ecology in paper form - by mail or in person (see addresses below). Email is not accepted.
