Your State Wastewater Discharge Permit No. ST0009266 is enclosed. This Permit satisfies the requirements of state laws. The Department of Ecology (Ecology) issues this permit in accordance with Chapter 90.48 RCW, as amended.

**Discharge Monitoring Report Forms**

Your new permit requires you to submit regularly scheduled **monthly** Discharge Monitoring Reports (DMRs) by using WQWebDMR which is Ecology's electronic data reporting system.

Please register online for your WQWebDMR account as soon as possible as your first DMR is due **March 15, 2013**. Step-by-step registration instructions, with screen shots, are enclosed and are also available: <http://www.ecy.wa.gov/programs/wq/permits/paris/webdmr.html>.

If you are unable to submit your DMR electronically (for example, you do not have an internet connection), you must contact Ecology to request a waiver to use WQWebDMR and obtain a paper DMR form. Please feel free to contact Ecology if you have any questions about WQWebDMR.

### **Permit Fees**

The Department of Ecology, in response to the passage of Initiative 97 in 1988, has adopted a regulation to recover costs associated with the issuance and administration of wastewater discharge permits (Chapter 173-224 WAC).

The annual fee for both industrial and municipal/domestic discharges is computed according to the permit fee schedules contained in WAC 173-224-040. The Department notifies permit holders of fee charges by mailed billing statements. Failure to pay the applicable permit fee may result in the suspension or revocation of the permit, and could result in the issuance of civil penalties or actions to enjoin the activity under the permit.

### **Appeal Process**

You have the right to appeal this permit within 30 days upon receipt of this document. Pursuant to chapter 43.21B RCW, your appeal must be filed with the Pollution Control Hearings Board, and served on the Department of Ecology, within 30 days of the date of your receipt of this document.

If you choose to appeal this action or decision, your notice of appeal must contain:

- (1) A copy of the permit you are appealing, and
- (2) A copy of the application for the permit.
