South Treatment Plant Reclaimed Water Cross Connection Control

The South Treatment Plant reclaimed water permit No. ST0007445, requires that King County notify all public water suppliers where reclaimed water is being used in their service area and remind the water suppliers of their duty to comply with the cross-connection control report requirements from the Washington State Department of Health.

South Treatment Plant reclaimed water is currently being used in the cities of Renton and Tukwila. These cities are the public water suppliers for the reclaimed water use areas. Figure 1, attached, shows the location of the reclaimed water permitted use areas. Enclosed are copies of the annual notification letters sent to the cities of Renton and Tukwila.



King County's South Treatment Plant produces and distributes reclaimed water under a permit from the Washington Department of Ecology (No. ST0007445). Permit condition R3.B requires King County to notify public water suppliers where reclaimed water is used in their service area and for what purpose. Additionally, King County must remind water suppliers of their duty to comply with the Washington State Department of Health's cross-connection control requirements.

The South Treatment Plant, King Conservation District, and City Soil Farm use Class A reclaimed water in the City of Renton. Figure 1, attached, shows the locations of the reclaimed water use areas within the City of Renton's Water Service Boundary. Reclaimed water is applied in permitted use areas in and around the South Treatment Plant for landscape, crop, and native plant nursery irrigation. Potable water is not connected to the irrigation systems. The reclaimed water use and sites are in accordance with the Washington State Water Reclamation and Reuse Standards and King County South Treatment Plant's reclaimed water permit.



South Treatment Plant Reclaimed Water Cross Connection Control

King County's South Treatment Plant produces and distributes reclaimed water under a permit from the Washington State Department of Ecology (#ST0007445). Permit condition R3.B requires King County to notify public water suppliers where reclaimed water is used in their service area and for what purpose. Additionally, King County must remind water suppliers of their duty to comply with the Washington State Department of Health's cross-connection control requirements.

The City of Tukwila, Starfire Sports, and Foster Golf Links use Class A reclaimed water in place of potable water for landscape irrigation; additionally, the City of Tukwila can use reclaimed water from a purple hydrant for sewer flushing, street sweeping, and irrigation. Figure 1, attached, shows the locations of permitted reclaimed water use areas within Tukwila's Water Service Boundary. Reclaimed water can be used in accordance with the Washington State Water Reclamation and Reuse Standards and King County South Treatment Plant's reclaimed water permit.
