Next Steps for American Legion Memorial Park Cleanup

The Washington Department of Ecology (Ecology) and the City of Everett (City) are planning to remove contaminated soil from American Legion Memorial Park and the Evergreen Arboretum in 2015. The park and arboretum soil contains arsenic above state cleanup standards in the top 1 to 2 feet of soil as a result of the historic operations of the Everett Smelter. While contamination in soil does not pose an immediate health risk, cleanup is important because it will protect people from exposure to arsenic.

Cleanup Plan Process

Cleanup work was recently rescheduled for 2015 to allow the City time to make changes to the scope of work. In November, the City will ask the public to submit their comments about the approach to park cleanup. A series of public meetings will be held by Ecology and the City (see below for schedule). A cleanup plan will be finalized by the end of 2014. Cleanup is tentatively scheduled to begin in summer 2015.

Next Steps

- Ecology is working with the Department of Archaeology and Historic Preservation to complete a cultural resource assessment of the park and arboretum. This will assess the likelihood that items of cultural significance are in the park. Local tribes have been consulted and were present during the field portion of the work.
- The City and Ecology will host three public meetings this fall to share information about cleanup and get feedback about plans for cleanup.
