Cleanup is Complete!

Environmental cleanup is complete at the Littlerock Grocery site. The site is located at 6410 128th Ave SW in Littlerock. It is currently a gas station and convenience store. Ecology proposes removing the site from the state's Hazardous Sites List.

We invite your comments on the proposed delisting from December 21 to January 22, 2017. The box on the left shows where you can find a No Further Action letter that describes why we believe no additional environmental cleanup work is necessary.

Why this Cleanup Matters

Soil and groundwater were tested for petroleum-related contamination as part of an environmental assessment in 1990. The test results indicated that groundwater was impacted by a leaking underground fuel storage system. The leak contaminated groundwater with BTEX (benzene, toluene, ethylbenzene, and total xylenes). Ecology placed the site on the state Hazardous Sites List based on these test results.

Cleanup Activities

To ensure safety of people and the environment, cleanup was confirmed under Ecology's Voluntary Cleanup Program. Cleanup activities included:

- Soil and groundwater testing to establish the extent and nature of the contamination.
- Establishing a groundwater monitoring system.
- Addressing petroleum contamination with natural attenuation.
- Testing soil and groundwater in 2016 for petroleum contamination to verify the success of cleanup.



What is the Hazardous Sites List?

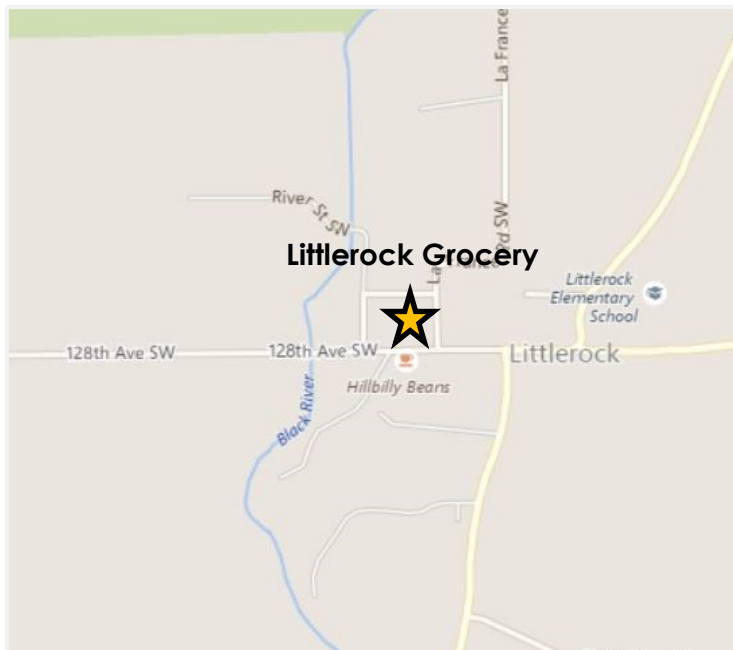
After Ecology has determined a site's potential threat to human health and the environment, it is placed on this list. Sites must go through cleanup and meet state standards before Ecology can remove them from the list.
