Cleanup is Complete!

Environmental cleanup is complete at the Lacey Food Mart site. The site is located at 4603 Lacey Boulevard SE in Lacey. It is currently a gas station and convenience store. Ecology proposes removing the site from the state's Hazardous Sites List, a statewide record of contaminated properties.

We invite your comments on the proposed delisting from December 21 to January 22, 2017. The box on the left shows where you can find a No Further Action letter that describes why we believe no additional environmental cleanup work is necessary.

Why this Cleanup Matters

Soil and groundwater at the site was contaminated with petroleum products. The contamination likely originated from a malfunctioning check valve released over 1,000 gallons of petroleum in the 1970s. The groundwater was contaminated with BTEX (benzene, toluene, ethylbenzene, and total xylenes). The site was placed on the state Hazardous Sites List based on these test results.

Cleanup Activities

To ensure safety of people and the environment, cleanup was confirmed under Ecology's Voluntary Cleanup Program. Cleanup activities included:

- Soil and groundwater testing to establish the extent and nature of the contamination.
- Establishing a groundwater monitoring system.
- Excavating over 2,200 tons of contaminated soil and disposing of it off-site.
- Treating over 6,500 gallons of impacted groundwater.
- Injecting oxygen into contaminated soil to stimulate petroleum breakdown.



What is the Hazardous Sites List?

After Ecology has determined a site's potential threat to human health and the environment, it is placed on this list. Sites must go through cleanup and meet state standards before Ecology can remove them from the list.
