### Proposed Removal from the Hazardous Sites List

The Washington State Department of Ecology (Ecology) is proposing to remove the Boulevard Nursery site, located at 2021 Boulevard Road SE, in Olympia, Washington, from its Hazardous Sites List.

Ecology is asking for your comments on the proposed removal of the site from the Hazardous Sites List. You are invited to:

- Review the Boulevard Nursery No Further Action Letter, which describes why Ecology believes cleanup is complete and does not pose a threat to human health or the environment.
- Send your comments to Ecology for consideration. Comments will be accepted January 4 – February 3, 2021.

### Site Background

The property is currently a vacant lot that was formerly a landscape nursery. An investigation in 2009 found the pesticides Dieldrin and DDT in soil collected on the property. The amount of pesticides found were below state cleanup levels, but Ecology determined more testing was needed. A second round of soil testing in 2020 found that pesticide concentrations did not trigger the need for cleanup. Based on these results, Ecology has concluded that no further action is needed at the site.

### What Happens Next?

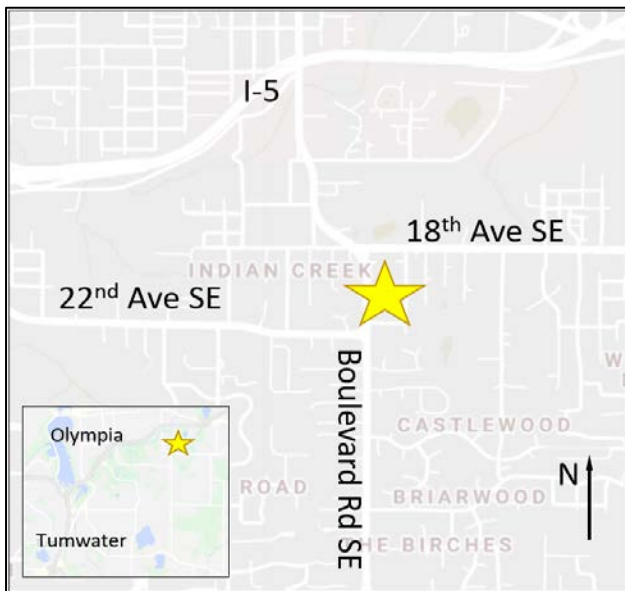
After the public comment period ends, Ecology will review comments received during the comment period. If no changes are necessary, the site will be removed from the Hazardous Sites List.

**What is the Hazardous Sites List?** A list of sites that Ecology has assessed for their potential threat to human health and the environment. Sites must go through cleanup and meet state standards before Ecology can remove them from the list.
