Site Cleanup Action to Start

The Washington State Department of Ecology (Ecology) has entered into an Agreed Order with Chevron Products Company and Burlington Northern Santa Fe Railway Company for implementation of a cleanup action plan for the Glacier Park – East site located to the east and north of Highway 2 and Chumstick Highway 209 in Leavenworth, Washington. An Agreed Order is a document agreed to by all parties that sets forth the activities that will occur to clean the site up.

Site Background

For more than 40 years petroleum fuel has been stored and distributed from this site. Incidental spills and leaks have contaminated the soils and groundwater at the site. To determine the source of contamination, estimate the extent of contamination, and evaluate cleanup options, a Remedial Investigation and Feasibility Study (RI/FS) was completed at this site during June 1997.

Selected Cleanup Action

The Feasibility Study (FS) focuses on options for site cleanup. The alternatives considered ranged from soil removal to capping the site with asphalt and groundwater monitoring. The selected cleanup action includes groundwater monitoring and capping of the site. This will involve the installation of three (3) groundwater monitoring wells.

For the first two years the groundwater will be sampled quarterly and maybe longer after that depending on the results. A report titled “Feasibility Study – Supplemental Information Supporting Remedial Alternative Recommendation,” dated May 27, 1999, contains detailed information regarding this selected cleanup option.

What’s Next?

Chevron Products Company and Burlington Northern Santa Fe Railway will start implementation of the Agreed Order to clean the site up. But, Ecology offers these documents for your review!

How Can You Be Involved?

You are invited to review and submit written comments on this agreed order. The 30-day public comment period will run from September 25, 2001 to October 25, 2001. Ecology will respond in writing to all comments received and the agreed order will be revised if necessary. The public is encouraged to participate in this process.
