Interim Action Plan and State Environmental Policy Act (SEPA) Determination of Non-Significance (DNS) Available for Public Review & Comment - Red Shirt Mill, Facility Site ID No. 55648558, Airport Road, Twisp, 98856, Okanogan County

The *Interim Action Plan* for the Red Shirt Mill site is available for public review and comment through March 28, 2003.

During the 1930s and 1940s, the Red Shirt Mill processed ore from the Red Shirt Gold Mine. Crushed rock left over from the mill process after the ore was extracted (called tailings) was left on-site and contaminated the soil with arsenic and lead.

In December 2002, the mill building was demolished and areas of the site with the highest levels of contamination were excavated.

The actions outlined in the Interim Action Plan call for adding organic matter to the tailings so they will be able to sustain plant growth. Once this has been completed, native grass, trees, and shrubs will be planted over the area. This will help reduce exposure of contaminants to humans and wildlife and enhance wildlife habitat.

Ecology has determined the actions will not have an adverse impact on the environment and has issued a SEPA DNS. This means an Environmental Impact Statement is not required.

Five-year Review Available for Public Review & Comment -

General Electric Co, Facility Site ID No. 630, 4323 E. Mission Ave., Spokane, 99212, Spokane County

Periodic review of a cleanup action is conducted no less than every five years after initiation of the action. Its purpose is to evaluate post-cleanup site conditions and monitoring data to assure human health and the environment are being protected. This review covers the 2nd quarter 1997 monitoring event up to and including the 2nd quarter 2002 ground water monitoring event.

The site was used by GE to operate a transformer service shop from 1961 to 1980. Oils containing polychlorinated biphenyls (PCBs) and Total Petroleum Hydrocarbons (TPH) were released to soils during service operations. Investigations in the mid to late 1980s confirmed PCBs and TPH in soils. PCBs were also found in ground water. Cleanup actions began in 1991. Remedies accepted as complete in 1999 included vitrification, removal, containment, and monitoring.

According to the review, the remedy is functioning as intended under the Cleanup Action Plan. Exposure pathways that could result in unacceptable risks are being controlled, and studies to date indicate PCBs from the site have not entered the Spokane River. The review recommends congener analysis in the ground water monitoring program and institutional controls in the form of deed restrictions where ground water is impacted.

Proposed Delisting from Hazardous Sites List Available for Public Review & Comment -

Ecology is *proposing to remove the Martinizing Gregsona LLC Summitview Ave site* from its Hazardous Sites List. The site is ranked “3” on the list. A rank of “1” is the highest assessed risk compared to other sites on the list, and a rank of “5” is the lowest.

Ecology is proposing to remove the site from the Hazardous Sites List, because samples have shown the ground water has met cleanup standards. As a result, Ecology has determined the site no longer poses a threat to human health or the environment.

Dangerous Waste Permit Modification and Remedial Investigation Report Available for Public Review & Comment - *Emerald Services Inc., 1825 Alexander Ave., Tacoma, 98421, Pierce County*

Emerald Services, Inc. is *proposing to modify its dangerous waste storage permit*. The changes apply to inspections, closures, contingencies, waste analysis, requirements for container management, and requirements for corrective action. The proposed modification requires Emerald Services to submit annual ground water data analysis reports to Ecology. In addition, the company has prepared a Remedial Investigation report. Both documents are available for review through April 17, 2003.

The previous owner of the facility conducted a Remedial Investigation in 2000. When Emerald Services assumed ownership, they became responsible for fulfilling the corrective action requirements to address releases and potential releases of dangerous wastes to soil or ground water.

The Remedial Investigation conducted by Emerald Services revealed there have been intermittent concentrations of hydrocarbons, arsenic, and lead in ground water that exceed cleanup standards. Ecology is recommending that they continue to monitor the ground water. A Feasibility Study will be required if continued monitoring indicates there has been a new release of hazardous substances or there is the potential for a release of hazardous substances to the soil or ground water.

Negotiations for Prospective Purchaser Consent Decree and Cleanup Action Plan - Custom Plywood, Facility Site ID No. 2685, 35th and V Street, Anacortes, 98221, Skagit County

Ecology and the City of Anacortes' Public Development Authority (PDA) *have commenced negotiations to develop a Prospective Purchaser Consent Decree* to implement a Cleanup Action Plan for the remaining undeveloped uplands portion of the former Custom Plywood site

The Custom Plywood facility is located on the western shore of Fidalgo Bay. It operated as a lumber and plywood mill since the 1920s. In 1992, a fire destroyed much of the main plywood manufacturing plant and releases of petroleum, metals, and polychlorinated biphenyls (PCBs) occurred. The facility has since been abandoned, and Ecology is working with the PDA, Washington State Office of Trade and Economic Development, and the Environmental Protection Agency (EPA) to consider cleanup options in combination with the EPA's Brownfields Redevelopment Program.

A Prospective Purchaser Consent Decree is legal document filed in court. It is negotiated and entered into prior to the purchase of a site. If the purchaser of the site (in this case, PDA) does not subsequently acquire the site, it is not bound by the terms of the Consent Decree. The work requirements in the decree and the terms under which it must be done are negotiated and will be agreed to by the PDA, Ecology, and the state Attorney General's Office.

A Cleanup Action Plan identifies the cleanup method(s) and specifies cleanup standards and other requirements at the site.

Once completed, the draft Prospective Purchaser Consent Decree and draft Cleanup Action Plan will be available for public review and comment.

Ecology and the US Army are *proposing an Enforcement Order* to investigate and clean-up the Camp Bonneville site, located approximately five miles from the Vancouver city limits. The Enforcement Order is available for review and comment through March 10, 2003.

The Department of Defense owned and operated Camp Bonneville for firing range practice and training from 1910 to 1995. During that time, military ammunitions were stored and used at the site—including artillery ammunition, mortar ammunition, air-launched rockets, shoulder-fired rockets, guided missiles, bombs, land mines (practice only), grenades, fuses, and small arms ammunition.

The camp was officially closed in 1995. Since then, investigations have been ongoing to characterize the contamination from the ammunitions and other hazardous substances and to develop a plan for re-using the site once it is cleaned up.

The Enforcement Order outlines the investigation and cleanup and calls for immediate removal of contaminated soils and debris from parts of the site. The ground water will also be analyzed and monitored to make sure the contamination is not migrating off-site.
