Agreed Order and Work Plan for Remedial Investigation/Feasibility Study Available for Public Review & Comment – Rayonier Mill, 700 N. Ennis, Port Angeles, 98362, Clallam County

Rayonier, Inc., the Lower Elwha Klallam Tribe, and Ecology have prepared an *Agreed order* and *Work Plan* to implement a Remedial Investigation/Feasibility Study at the upland portion of the former Rayonier Mill site. These documents are available for public review and comment through May 7, 2003.

The former Rayonier Mill site is located along the waterfront at the east end of Port Angeles Harbor on a combination of native soils, beach deposits, and imported fill. Ennis Creek flows through the site and empties into the Strait of Juan de Fuca.

Over the operational life of the mill, liquid and semi-solid wastes were discharged into Port Angeles Harbor and into the Strait of Juan de Fuca through a series of outfall pipes. Fly ash and flue gases were emitted from boilers that burned combinations of fuel oil and wood waste to produce steam used in the pulping process. The amounts, composition, and discharge locations of these wastes varied. Over time, control requirements became more stringent. However, in addition to releases allowed under the mill's environmental permits, there were episodic spills and pollution releases that exceeded accepted levels.

The purpose of the Remedial Investigation is to determine the nature and extent of the contamination in soil, surface water, ground water, and fresh water sediments. With that information, a Feasibility Study will be prepared to develop and evaluate alternatives for cleaning up the site.

Public Comment Period Extended – US Army Camp Bonneville, Remedial Action Unit 1, Remedial Action Unit 2, and Remedial Action Unit 3, Facility Site ID No. 5093080, Facility Site ID No. 9420069, Facility Site ID No. 5125990, Proebstel, Clark County

Ecology and the US Army are *proposing an Enforcement Order* to investigate and clean-up the Camp Bonneville site, located approximately five miles from the Vancouver city limits. The public comment period to review and comment on the Enforcement Order has been extended through May 15, 2003.

The Department of Defense owned and operated Camp Bonneville for firing range practice and training from 1910 to 1995. During that time, military ammunitions were stored and used at the site—including artillery ammunition, mortar ammunition, air-launched rockets, shoulder-fired rockets, guided missiles, bombs, land mines (practice only), grenades, fuses, and small arms ammunition.

The camp was officially closed in 1995. Since then, investigations have been ongoing to characterize the contamination from the ammunitions and other hazardous substances and to develop a plan for re-using the site once it is cleaned up.

The Enforcement Order outlines the investigation and cleanup and calls for immediate removal of contaminated soils and debris from parts of the site. The ground water will also be analyzed and monitored to make sure the contamination is not migrating off-site.

Pursuant to *WAC 173-340-545 Private Right of Action*, Johannessen & Associates P.S., on behalf of its client Cascade Investors, has given notice that an independent cleanup will be conducted at the above-referenced property.

The site is the location of a former gas station. Recent investigations have confirmed the soil has concentrations of xylene above Method A cleanup standards and both the soil and ground water have concentrations of total petroleum hydrocarbons-gasoline, benzene, and ethylbenzene above Method A cleanup standards.

Cascade Investors intends to start cleanup activities no earlier than April 27, 2003.

Background Information:

The Washington State Legislature appropriated \$1.2 million to prepare a statewide strategy to address area-wide soil contamination. The main focus for the project will be on areas with low to moderate levels of lead and arsenic that have been developed into residential neighborhoods, schools, daycares, and parks. The departments of Ecology, Agriculture, Health, and Office of Community Development are examining these issues and concerns and will develop a more effective strategy for responding to widespread arsenic and lead-soil contamination.

A central feature of the project is the Area-Wide Soil Contamination Task Force. Their role is to provide a recommendation to the four agencies on actions that can be taken to improve the ways in which area-wide soil contamination problems are addressed in Washington State.

The task force is comprised of 18 members, including representatives of local government, elected officials, agriculture, environment, business/development, finance, and education/schools. They are expected to complete their work by June 2003.

Draft Cleanup Action Plan and State Environmental Policy Act (SEPA) Determination of Non-Significance (DNS) Available for Public Review & Comment – *South Wilbur Petroleum Contamination Site, Facility Site ID No. 7096, Front Ave. & Knox & Ann St., Wilbur, 99185, Lincoln County*

The *draft Cleanup Action Plan and SEPA DNS* for the South Wilbur Petroleum Contamination site are available for public review and comment through April 24, 2003.

The site consists of three properties: the Washington State Department of Transportation Facility, which operated from the early 1930s to 1996; the Lincoln County Maintenance Facility, which Page 3 been in operation since the early 1930s; and the former Lincoln Mutual #3 fueling station, which operated from the 1960s through the 1980s.

The draft Cleanup Action Plan describes cleanup actions proposed for the site and is based on information gathered during the Remedial Investigation/Feasibility Study. Results of the Remedial Investigation indicate that shallow ground water is contaminated with gasoline, diesel, benzene, ethylbenzene, and xylene. Shallow soil is contaminated with gasoline and minor amounts of diesel fuel.

Ecology has selected source removal, engineering controls, and enhanced bioremediation for the remedial action. It includes the following:

- Excavating contaminated soil and treating off-site;
- Backfilling excavated areas with a mix of clean fill and an oxygen releasing compound;
- Installing engineering controls, which include asphalt pavement, storm water controls, and installing a phytoremediation barrier (plants) on the north and west sides of the site;
- Implementing institutional controls to maintain the integrity of the cleanup action.

After review of the Environmental Checklist and other site-specific information, Ecology (as the lead agency) has determined the cleanup action will not have a probable adverse impact on the environment and has issued a SEPA DNS.
