### **Proposed Delisting from Hazardous Sites List Available for Public Review & Comment – Pope & Talbot Industrial Landfill 1, Facility Site ID No. 93181417, Teekalet Ave., Port Gamble, 98364, Kitsap County**

Ecology is *proposing to remove* the Pope & Talbot Industrial Landfill 1 site from its Hazardous Sites List. The site is ranked “2” on the list. A rank of “1” is the highest level of concern compared to other sites on the list, and a rank of “5” is the lowest.

Pope & Talbot, Inc. operated Landfill 1 from the 1950s to 1980s to store waste from its sawmill operations. The landfill contained approximately 30,000 cubic yards of waste and covered an area of approximately 90,000 square feet. The waste included bark, wood debris, steel banding, and dredge sediments.

From March to August 2002, the waste was excavated and sent to a permitted solid waste facility for disposal. After the excavation, the soil, sediments, and ground water were sampled for petroleum hydrocarbons and heavy metals and were found to meet state cleanup standards.

Based on the sampling results, Ecology has determined the site no longer poses a threat to human health or the environment and is proposing to remove the site from the Hazardous Sites List.

**Consent Decree, Remedial Investigation/ Feasibility Study Report, Cleanup Action Plan, and State Environmental Policy Act (SEPA) Determination of Non-Significance (DNS) Available for Public Review & Comment Action – *Roderick Timber, Facility Site ID No. 4061791, 712 Hagara St., Aberdeen (Junction City), 98520, Grays Harbor County***

Ecology, the City of Aberdeen, and the Grays Harbor Historical Seaport Authority are *proposing a Consent Decree to implement a Cleanup Action Plan* at the Roderick Timber site. These documents, along with the Remedial Investigation/Feasibility Study report and SEPA DNS are available for review and comment through June 27, 2003. Roderick Timber is ranked “1” on the Hazardous Sites List.

The 295-acre Roderick Timber site is a former truck maintenance shop, landfill, and log sort yard. It is in the Chehalis River floodplain and was originally wetlands. The metal building on the property is currently being used as a facility for building wooden ships and training shipbuilding and woodworking students. Sierra Pacific Lumber Company owns the western portion of the property and has entered Ecology’s Voluntary Cleanup Program to clean up that area independently.

The Cleanup Action Plan describes cleanup actions proposed for the site (excluding the western portion) and is based on information gathered during the Remedial Investigation/Feasibility Study. It proposes the following:

- Excavate contaminated ditch surface sediment and soil;
- Cover fenced area with gravel;
- Construct a specially engineered treatment ditch (bio-swale) and install a ground water interception trench to route contaminated ground water to the bio-swale and away from other ditches;
- Cap garbage with soil and vegetation;
- Plant vegetation that can draw metals from the soil around the landfill perimeter, as needed;
- Monitor ground water and bio-swale surface water to verify effectiveness of the cleanup;
- Place restrictions on the property deed to ensure future owners do not disturb the cap and will continue to maintain the elements of the cleanup.

After review of the Environmental Checklist and other site-specific information, Ecology has determined the cleanup action will not have a probable adverse impact on the environment and has issued a SEPA DNS.

**Agreed Order for Remedial Investigation/Feasibility Study Available for Public Review & Comment – Harris Avenue Shipyard, Facility Site ID No. 2922, 201 Harris Ave., Bellingham, 98225, Whatcom County**

Ecology and the Port of Bellingham are *proposing an Agreed Order to conduct a Remedial Investigation/Feasibility Study* at the Harris Avenue Shipyard site. The Agreed Order is available for public review and comment through July 9, 2003. Harris Avenue Shipyard is ranked “2” on the Hazardous Sites List.

The purpose of the Remedial Investigation is to determine the nature and extent of sediment contamination at the site. With that information, a Feasibility Study will be prepared that evaluates cleanup alternatives.

In 2000, Ecology identified Harris Avenue Shipyard as a high priority for cleanup in a comprehensive strategy developed in cooperation with the Bellingham Bay Demonstration Pilot Workgroup. It is one of 12 cleanup sites around Bellingham Bay identified through the workgroup.

Sampling conducted over the years indicates the main contaminants of concern are copper, zinc, polychlorinated biphenyls, and phenol. A draft Sampling Plan is included in the Agreed Order that identifies sampling needed to supplement existing data.

## **Proposed Delisting from Hazardous Sites List Available for Public Review & Comment - *Carburetor Ignition (formerly A-1 Auto Wrecking), Facility Site ID No. 732, 433 East Sprague Avenue, Spokane, 99202, Spokane County***

Ecology is *proposing to remove the Carburetor Ignition* site from its Hazardous Sites List. The site is currently ranked “3” on the list. A rank of “1” is the highest level of concern compared to other sites on the list, and a rank of “5” is the lowest.

During the A-1 Auto Wrecking time of operation, wrecked automobiles were stored on the north side of the site in an unpaved yard. Auto salvage activities resulted in the releases of waste oil, metals, methyl tertiary butyl ether (MTBE), and polychlorinated biphenyls (PCBs) to the soil.

In 1994, Ecology conducted a site hazard assessment of the property, and ranked the site “3.” Between 1994 and 2003, contaminated soil was removed from the site. Sampling conducted after the removal confirmed that contamination was no longer at the site. The property is currently used for rebuilding vehicle carburetors.

The recommendation for removal from the Hazardous Sites List is based on Ecology’s review of a Final Independent Cleanup Report submitted in November 2002. This report was completed under the Voluntary Cleanup Program (VCP). Based upon review of this report and supporting VCP documents, Ecology has concluded the site no longer represents a threat to human health and/or the environment, the remedial actions conducted at the site satisfy the intent of the Model Toxics Control Act, and No Further Action is needed.

**Proposal to Remove Restrictive Covenant from Site – Unocal 0171 (also known as Unocal Stanwood Former Bulk Plant 0171 and Service Station 4372), Facility Site ID No. 36615236, 8513 Cedarhome Dr., Stanwood, 98292, Snohomish County**

Ecology is proposing to remove a **Restrictive Covenant** from the Unocal BP 0171 site. The Restrictive Covenant was placed on the property deed last year, because TPH-contaminated ground water remained on site. In order for the site to receive a No Further Action determination from the Voluntary Cleanup Program, a Restrictive Covenant was required to restrict ground water use until cleanup standards were achieved.

Additional sampling conducted throughout 2002 has confirmed that the contamination is now below state cleanup standards. Based on this information, Ecology is proposing to remove the Restrictive Covenant.

**Consent Decree to Resolve Liability Available for Public Review & Comment – Banks Property (aka J.C. Penney Company), Facility Site ID No. 538, 102 N. Naches Ave., Yakima, 98901, Yakima County**

Ecology and the J.C. Penney Company are **proposing a Consent Decree** to settle J.C. Penney's liability related to contamination and cleanup costs at the Banks Property site. The Banks Property site is one of 13 sites that make up the Yakima Railroad Area site. Banks Property is ranked "3" on the Hazardous Sites List.

J.C. Penney operated an automotive parts and service department on the property until 1983. In 1993, petroleum product, perchloroethylene (PCE), methylene, and chloride were discovered when an underground storage tank the company used was removed.

In 1999, Ecology and J.C. Penney entered into an Agreed Order to conduct a Remedial Investigation and Interim Action at the site. The results of the investigation confirmed the contamination is not at levels that are a threat to human health and the environment; however, the ground water will continue to be monitored.

Since J.C. Penney has met its obligations for cleanup as stated in the 1999 Agreed Order, Ecology and J.C. Penney are proposing the Consent Decree to settle Ecology's claim against J.C. Penney for contamination and cleanup costs at the Banks Property site. Other potentially liable persons (PLPs) are still liable at the site.

**Agreed Order to Conduct Remedial Investigation/Feasibility Study, Interim Action, and Cleanup Action Plan Available for Public Review & Comment – *Pacific Wholesale, Facility Site ID No. 1199, S. Terminus 3<sup>rd</sup> St., Raymond, 98577, Grays Harbor County***

Ecology and the City of Raymond are *proposing an Agreed Order to conduct a Remedial Investigation/Feasibility Study, Interim Action*, and prepare a *Cleanup Action Plan* at the Pacific Wholesale site. The Agreed Order is available for public review and comment through June 30, 2003.

The +3-acre site was formerly used to warehouse/wholesale industrial and building supplies. Other uses of the property include a lumber company, car dealership, car repair shop, and power saw repair/retail shop.

During a 1992 environmental audit, numerous 50-gallon barrels of solvents were discovered, along with waste oil. Further sampling confirmed elevated levels of petroleum hydrocarbons in soil. Last March, an arson fire destroyed most of the on-site buildings, leaving behind partially-burned wood, metal, pilings, and other debris.

The purpose of the Remedial Investigation is to determine the nature and extent of soil contamination and potential ground water and sediment contamination. Under the Feasibility Study, information gathered during the Remedial Investigation will be used to evaluate cleanup alternatives. The Interim Action will include removing building debris and contaminated soil. Once the Remedial Investigation/Feasibility Study is finished and approved, a Cleanup Action Plan will be completed that will list the preferred cleanup remedy for the site.

**Draft Engineering Design Report Available for Public Review & Comment – Yakima Valley Spray, Facility Site ID No. 445, 1108 S. 1<sup>st</sup> St., Yakima, 98901, Yakima County**

The *Engineering Design Report* for the Yakima Valley Spray site is available for public review and comment through June 16, 2003. This report provides engineering concepts and design criteria that will be used for designing the cleanup action. The report also contains a Storm Water Pollution Prevention Plan, Sampling and Analysis Plan, Health and Safety Plan, and Ground Water Compliance Monitoring Plan. Yakima Valley Spray is ranked “1” on the Hazardous Sites List.

The Yakima Valley Spray site is contaminated with 62 contaminants underlying the soil and ground water. The main contaminants of concern include arsenic, PCE (a solvent), gasoline, diesel, oil, benzene, and pesticides (aldrin, dieldrin, DDD). The cleanup action will include the following:

- Monitoring air during construction planned for winter of 2003-2004;
- Sampling and demolition/removal of two on-site buildings;
- Excavating and disposing of large pesticide pit;
- Excavating and disposing of total petroleum hydrocarbon (TPH) pit(s);
- Backfilling excavated pits;
- Bioventing/biosparging remaining PCE/TPH contamination;
- Replacing destroyed monitoring wells and installing five new monitoring wells;
- Monitoring ground water for five years;
- Placing institutional controls to limit use of site to commercially-zoned purposes and to restrict use of site ground water.
