Gebbers Farms in Brewster, Cleanup Complete, Ecology Proposes to Issue a Notice of Satisfaction

The Washington State Department of Ecology is proposing to issue a Notice of Satisfaction of the Enforcement Order for a Remedial Investigation/Feasibility Study (RI/FS) at this contaminated site. The site is located on P & G Road adjacent to the migrant worker camp and railroad tracks approximately 1.5 miles northeast of Anderson Field near Brewster. During June 2002, three groundwater-monitoring wells were installed and the soil was also sampled. As a result of the soil and groundwater sampling, Ecology has determined that the site does not pose a threat to human health or the environment and is now proposing to issue this Notice of Satisfaction of the Enforcement Order. The public is invited and encouraged to comment on this action. A 30-day public comment period will run from May 12, 2004 through June 11, 2004.

D Draft Prospective Purchaser Consent Decrees Available for Public Review &

Comment – Everett Smelter Site, SR 529 & East Marine View Drive, Everett, 98201, Snohomish County

Ecology and the prospective purchaser of portions of the Everett Smelter site, the Everett Housing Authority (EHA), are *proposing two Consent Decrees to implement cleanup work* at the site. One consent decree addresses EHA's liability within the Fenced Area where the most contaminated soil in the area is located. The other addresses EHA's liability for 15 homes currently owned by ASARCO, Inc. These agreements specify and limit EHA's liability for known contamination from smelter activity with respect to the property it purchases. These agreements do not relieve Asarco of any responsibility at the Everett Smelter site.

This approximately 600-acre site is contaminated by arsenic, lead, and other metals. The contamination was caused by emissions from the Everett Smelter and by material left behind when the smelter was demolished.

The property transaction includes the following:

- EHA will purchase 15 Asarco-owned homes outside the Fenced Area and accept liability for cleaning remaining contamination up to residential standards;
- Asarco will clean up the contaminated yards of the 15 Asarco-owned homes outside of the Fenced Area as part of the purchase and sale agreement;
- This purchase and sale agreement also requires Asarco to clean up contaminated yards at an additional 22 homes in the area which are not owned by Asarco;
- Asarco will clean up the Fenced Area as a condition of the purchase and sale agreement; and
- After Asarco has removed the most contaminated soil from the Fenced Area (more than 3,000 parts per million arsenic), EHA will purchase this area from Asarco and accept liability for cleaning up the remaining arsenic-contaminated soil to residential standards.

C Ecology Proposes An Agreed Order With Burlington Northern Santa Fe Railway

Company (BNSF) - *East "D" Street, from East 21st Street (now the Highway 509 right-of-way) north to East 15th Street, Tacoma, 98421*

This proposal is to conduct an interim action and remedial investigation/feasibility study (RI/FS) of petroleumcontaminated soil and groundwater. The interim action includes stopping migration of petroleum-related contamination into Thea Foss Waterway. The 1/2-mile BNSF Oil Pipeline, installed in the early 1900's, connects historic oil storage tanks located on property now owned by JM Martinac with oil storage tanks on the current BNSF Tacoma Rail yard. In addition to BNSF, Ecology has identified the Washington State Department of Transportation, City of Tacoma, Supervalu Holdings, Home Electric, and Nichols Trucking as potentially liable persons for this site. However, they did not sign the agreed order.

□ Proposed Delisting From Hazardous Sites List Available For Public Review & Comment – Spokane Custom Wood Treating, *Facility Site ID No.690, 728 North Perry Street, Spokane, 99201, Spokane County*

Ecology is *proposing to remove the Spokane Custom Wood Treating site* from its Hazardous Sites List. This site is ranked a three on the Hazardous Sites List. A rank of "1" is the highest level of concern compared to other sites on the list, and a rank of "5" is the lowest.

Spokane Custom Wood Treating operated from the mid 1970s until 1995-96. Sampling done at the site showed pentachlorophenol (penta), copper naphthenate, diesel and polycyclic aromatic hydrocarbons (PAHs) in soil at levels above what is allowed by state regulations. PAHs are a byproduct of the incomplete burning of organic substances such as diesel. Follow-up sampling did not detect penta or diesel in groundwater.

Cleanup included sampling of soil and groundwater, removal of an underground storage tank, removal of limited amounts of soil, including 180 cubic yards of contaminated soil and hazardous materials, management and disposal or treatment of hazardous and special wastes and closing the facility.

Samples taken after soil removal showed some contamination remained in the hoist, vault and dip tank areas. This soil will be covered with asphalt to isolate and contain the contamination. A water management system will be installed to prevent storm water from running through contaminated soil into groundwater. A restrictive covenant was placed on the property because of remaining contamination in soil. This restrictive covenant will stay on the property after the site is removed from the Hazardous Sites List.

Based on review of the Final Independent cleanup report and supporting documents, Ecology has concluded:

- The site no longer represents a threat to human health and/or the environment.
- Cleanup actions conducted at the site satisfy the intent of the Model Toxics Control Act (MTCA).
- NO FURTHER ACTION is needed.

□ Proposed Delisting From Hazardous Sites List Available For Public Review & Comment – Yellowstone Pipeline Otis Orchards, *Facility Site ID No. 66374131, 6311* Malvern Road, Otis Orchards 99027, Spokane County

Ecology is *proposing to remove the Yellowstone Pipeline Otis Orchards site* from its Hazardous Sites List. This site is ranked a two on the Hazardous Sites List. A rank of "1" is the highest level of concern compared to other sites on the list, and a rank of "5" is the lowest.

In October 1996, a pinhole-sized leak in the pipeline released an unknown amount of petroleum product to soil and groundwater. The leak was discovered during a routine test of the pipeline.

Cleanup included removal of contaminated soil when the pipeline was exposed for inspection and when soil vapor extraction wells were installed. A pilot test was done to see if soil vapor extraction would be an effective treatment for contamination. The treatment technology created a vacuum to pull petroleum vapors from soil.

Once these vapors were removed, it would be less likely that groundwater would continue to be contaminated. However, the results of the pilot study showed the treatment was not effective.

Because of these findings, a cleanup method was chosen that required continued groundwater monitoring. Groundwater monitoring continued from 1997 through 2003. Samples collected in 2002 and 2003 showed contamination was below levels required by the state.

Based on review of the Final Independent cleanup report and supporting documents, Ecology has concluded:

- The site no longer represents a threat to human health and/or the environment.
- Cleanup actions conducted at the site satisfy the intent of the Model Toxics Control Act (MTCA).
- NO FURTHER ACTION is needed.

Proposed Delisting from Hazardous Sites List – Former Able Pest Control (a.k.a. 62nd Avenue Property), Facility Site ID No. 62948929, 18115 62nd Avenue NE, Kenmore, 98037, King County

Ecology is proposing to remove the former Able Pest Control site (a.k.a. 62nd Avenue Property) from the Hazardous Sites List. The site is currently ranked a "2." Comments will be accepted between May 5 and June 3, 2004.

Able Pest Control operated a pest extermination business at the site from 1969 until 1986. The pesticides chlordane and dieldrin were found on site in soil at levels above state residential cleanup standards, likely a result of the handling of pesticides during that time. The site is the location of the former Able Pest Control, and includes a portion of the adjacent Lake Forest Park Preschool.

An emergency agreed order was issued by Ecology due to the potential for children at the preschool to be exposed to pesticides. Soil was removed from the site between 1998 and 2000. Based on monitoring reports, Ecology has determined that the site now meets soil cleanup standards.

While cleanup at the site already has occurred, changes to the existing Cleanup Action Plan also are proposed including: revising specific sections of the document that relate to earlier assumptions about a shallow groundwater pocket at the site, requiring additional soil sampling on the adjacent preschool property to confirm that the cleanup worked, and decommissioning of some shallow monitoring wells. *The delisting is not contingent on the additional monitoring at the preschool.*

Proposed Delisting From Hazardous Sites List Available For Public Review & Comment – Former Unocal Service Station 0855, Okanogan County

Ecology is *proposing to remove the Unocal Service Station 0855 site* from its Hazardous Sites List. This site is located at 129 N Main Street in Omak, Washington. The site operated as a retail gasoline service station from approximately 1930 to 1980. The former fuel storage and distribution operations included eight gasoline underground storage tanks (USTs), underground dispenser piping, a pump island, a heating oil UST, a waste oil UST, and two fuel oil aboveground storage tanks; all of this equipment has since been removed from the site.

In July 1994, the Okanogan County Health District conducted a Site Hazard Assessment. As a result, the site was ranked a "2" and was placed on the Hazardous Sites List. A 1 represents the highest relative risk and 5 represents the lowest.

As a result of the remedial activities that have taken place at this site since 1993, Ecology has determined that the site does not pose a threat to human health or the environment and is now proposing to remove this site from the Hazardous Sites List.
