■ Notice of Proposed Consent Decree and Cleanup Action Plan for Tiger Oil Site, 24<sup>th</sup> and Nob Hill Boulevard, Yakima County

Ecology is proposing to enter into a Consent Decree with Tiger Oil Corporation (Tiger) and Federated Service Insurance Company under the authority of Chapter 70.105D RCW, the Model Toxics Control Act. The Consent Decree states that Tiger will implement the proposed Cleanup Action Plan for the Tiger Oil Site (Site). In addition, Ecology has issued a Determination of Non-Significance for work to be completed under the CAP

In 1982, approximately 18,772 gallons of petroleum product were released from the underground storage tank system at the retail petroleum station. Additional known releases of approximately 2,000 gallons and 50 gallons were reported to have occurred in 1983 and 1984, respectively. The released petroleum product has contaminated the soil and groundwater on the Tiger Oil station property and an adjacent property. Tiger purchased the station in October 1987. A Remedial Investigation and Feasibility Study (RI/FS) was completed, and an interim remediation system, consisting of a groundwater and soil vapor extraction (SVE) system, has been operating since 1995 to reduce the level of soil and groundwater contamination and to prevent off-site migration of petroleum product.

Ecology and Tiger have developed a Cleanup Action Plan to address the contamination. Planned cleanup actions at include continued operation of the groundwater treatment system, expansion of the soil vapor extraction system, underground storage tank (UST) removal, soil removal, natural attenuation, and groundwater monitoring. Further expansion of the soil vapor extraction system may be installed if testing results indicate that it is warranted.

After reviewing the State Environmental Policy Act environmental checklist, Ecology has determined that the cleanup actions will not have a probable significant adverse impact on the environment, and an Environmental Impact Statement is not required.

# Notice of Proposed Settlement of Kaiser Aluminum's Mead Smelter Superfund Cleanup Site, 2111 E Hawthorne Rd., Mead, WA, Spokane County.

Ecology, United States Environmental Protection Agency and Kaiser Aluminum Corporation have reached a settlement to clean up cyanide and fluoride contamination found at the Kaiser Aluminum smelter. The 20 million dollar settlement is the result of bankruptcy negotiations between the two governmental agencies and bankrupt Kaiser Aluminum Corporation, and will, if approved by the bankruptcy court, release Kaiser Aluminum Corporation from liability for further cleanup costs under both the state and federal cleanup statutes. The settlement involves transferring the site to an independent Trust which will be set up to administer both cleanup funds and future work paid for by an environmental cleanup insurance policy.

Prior to bankruptcy in 2002, Kaiser Aluminum & Chemical Corporation owned and operated an aluminum smelter approximately seven miles north of downtown Spokane. The smelter was constructed in 1942 during World War II to supply aluminum to the war effort. The plant operated eight potlines, a prebake anode production facility with bake ovens, and. a coke calciner. At full capacity, the plant produced in excess of 640 tons of aluminum a day. The aluminum plant has been sold to Commercial Development Corporation and will be redeveloped as commercial real estate. The Superfund cleanup site is located on the north side of the plant complex and consists of a 128,000 ton pile of smelting wastes. These wastes contain cyanide and fluoride, which has leached out of the pile into the underlying soils and groundwater. Contaminated groundwater containing cyanide and fluoride travels about 2 miles to discharge to the Little Spokane River.

The Draft Consent Decree provides for a court-appointed Trust to continue cleanup at the site. The preferred cleanup option for the site consists of: consolidation of the potliner waste into one pile and covering the pile with an engineered cap: evaluation of the water piping surrounding the consolidated pile, along with repair of any leaking piping; and the potential pumping and treatment of contaminated found in soil beneath the pile.

Using monies from the environmental insurance policy, the Trust will replace and inspect water system pressure mains located in the groundwater recharge area surrounding the potliner pile. The Trust will construct a new groundwater monitoring system and establish a point of compliance at the site property boundary. After five years, the Trust will evaluate the results of the groundwater monitoring to determine if the interim actions already in place (the cap on the waste pile and repair of leaking pipes) have been effective in cleaning up the aquifer. If not, further remedial actions will be investigated, beginning with an evaluation of whether a pump and treat system can be effective at removing cyanide and fluoride in the groundwater beneath the site. The environmental insurance policy will be used to fund the construction and maintenance of the pump and treat system or other necessary remedial measures.

Alexander Farms Draft Plans For Final Cleanup, Consent Decree and SEPA DNS, Available For Public Comment, 179301 and 179101 King Cole Tull Road, Grandview, WA, 98930, Benton County

The Department of Ecology is asking the public to comment on a draft Cleanup Action Plan (CAP), a draft Consent Decree (CD), and a State Environmental Policy Act (SEPA) Determination of Non-Significance (DNS) for the Alexander

Farms Toxic Cleanup Site in Grandview. The CAP and CD are part of an agreement between the Alexander's and the Department of Ecology to clean up soil contamination and monitor a groundwater contamination plume located on their property. Ecology is also requesting comments on the SEPA DNS which is being issued for the proposed soil and groundwater cleanup.

In 1998, Ecology responded to complaints of yellow water coming from two domestic wells in the vicinity of the Alexander Farms site. Ecology determined that the soil and groundwater at the site was contaminated with Dinoseb, an herbicide that was banned from use by the USEPA in 1986.

After soil removal and cleanup stalled in fall of 1998, Ecology asked EPA to intervene. EPA, under its Superfund authority, hired a contractor to remove some 12,530 tons of contaminated soil from the site in 1999. Approximately 1,600 cubic yards of Dinoseb-contaminated soil remain at the site. In accordance with the CAP, the contaminated soil will be excavated and hauled to a licensed disposal facility.

The groundwater contamination plume beneath the site has been decreasing in size and concentration since the EPA conducted their soil removal. Under the CAP, groundwater will be monitored until it consistently measures below 7 ug/L (the level considered to be safe by the EPA).

Ecology has determined no probable adverse impact on the environment and proposes to issue a Determination of Non-Significance (DNS) under the State Environmental Policy Act (SEPA, chapter 197-11 WAC) Rules.

# ☐ Briggs Nursery Agreed Order for Remedial Investigation/Feasibility Study (RI/FS) Proposed, 4407 Henderson Boulevard SE, Olympia, WA 98501

Ecology, Briggs Nursery, Inc., and Gary E. Briggs, have agreed to a Model Toxics Control Act (MTCA, Chapter 70.105D RCW) order to conduct a remedial investigation/feasibility study (RI/FS) and risk assessment. This assessment addresses soil, sediment, ground water, and surface water contaminated with pesticides, metals, PCBs and dioxins/furans at the 120-acre semi-active Briggs Nursery site.

The Agreed Order ensures that site investigative and assessment activities are conducted in a timely fashion, in accordance with MTCA and other applicable regulations.

Interested citizens may review and comment on this proposed Agreed Order through **August 31, 2004**. You are also invited to a Public Meeting on **August 11, 2004** to discuss the proposal, ask questions, and offer comments or concerns. This meeting will be held at the Briggs YMCA, located at 1530 Yelm Hwy SE, Olympia, from **7:00-9:00** pm. Carpooling is encouraged. The meeting will focus on issues covered by this Agreed Order only.

Briggs Nursery borders Ward Lake on the east and includes six *kettles* (natural craters or large holes formed from ice that has separated from a glacier) which collect and hold stormwater from nursery operations, Henderson Boulevard, and undeveloped areas. The site consists of undeveloped land, plant growing operations, greenhouses, a warehouse, shop,

chemical storage trailers, an office building, and laboratory. An on-site deep water well is used for irrigation. The land is currently scheduled for development as the Briggs Urban Village and contamination must be identified and removed before development can begin.

Investigations conducted in 1996 and 2000 identified pesticides (DDE, DDT), metals (thallium, arsenic, chromium), PCBs (polychlorinated biphenyls), and dioxin/furans in soil. A 1998 study discovered two underground storage tanks, several septic systems, and chemical mixing areas with evidence of spillage. Run-off from these chemical mixing areas empties into the kettles. Surface water and wastewater from some plumbing fixtures also flow to the kettles. In 2003, Ecology observed stormwater and sediment flowing from the site to Ward Lake through overflow pipes from the northeast kettle.

Starting in August 2002, Briggs Nursery, Inc. and Gary Briggs cleaned up a 5-acre piece of the site (called the Briggs Nursery Debris Field) by removing buried solid waste and pesticide-contaminated soil and sediment. This section of the site was removed from the Hazardous Sites List in October 2003 and is not part of this Agreed Order.

☐ Philip Services Corporation (PSC)-Georgetown recently requested a modification to their hazardous/dangerous waste permit (the facility has also been known in the past as Chemical Processors ("Chempro") and Burlington Environmental), located at 734 S. Lucile St., Seattle, WA

PSC has recently requested a modification to their hazardous/dangerous waste permit. This request concerns the completion due dates for their Remedial Investigation and submitting a draft Feasibility Study Report. The public comment period associated with this request will start on July 19 and last for 60 days. A public meeting has been tentatively scheduled for August 31 at the Eagles Hall in Georgetown.

Releases from operations at the facility, including storage of wastes and chemicals in underground storage tanks, going back over 50 years, have contaminated on-site soils. Groundwater contamination has been detected between the facility and East Marginal Way (to the west). The facility closed as a hazardous/dangerous waste storage facility in 2003 and the facility property is not currently being used commercially. In early 2004, a subsurface barrier wall was constructed around the facility to contain contaminated groundwater on-site. A number of "vapor intrusion" mitigation systems have been installed in the down gradient area to protect buildings from VOCs in shallow groundwater, which are sufficiently concentrated to pose a threat to indoor air quality. PSC submitted their Remedial Investigation Report of the site in November 2003.

The property covers four acres and was historically used for storage, maintenance, and fueling of city vehicles from the 1950s through the present. Petroleum from leaking underground storage tanks contaminated soil and groundwater during the past years of operation.
