#### **CHELAN COUNTY**

Dryden Landfill, 9073 Highway 2, Dryden

Public comment period: 11/9/05 – 12/9/05

Agreed Order for Monitoring and Site Use Restrictions

The Dryden Landfill has been operated as a landfill by Chelan County since 1960. In 1986, limited closure activities took place, including the installation on a sub-standard cover over the landfill and the installation of four monitoring wells to conduct groundwater monitoring.

In June 2004, Chelan County submitted an amended closure plan to Ecology. This included the installation of an approved cover, over the landfill, in accordance with the requirements of WAC Chapter 173-304, Minimal Functional Standards. It also included the filing of a restrictive covenant with the Chelan County Auditor's Office to restrict future uses of the site. Groundwater monitoring, surface water monitoring, gas monitoring, ground settling monitoring, maintenance of the facility and its structures, maintenance of the vegetative layer, and maintenance of the monitoring systems will be conducted on an ongoing and regular basis.

This approved closure plan provides regular monitoring activities and restrictions on site use. These measures minimize threats to human health or the environment.

A public comment period offers an opportunity to have your ideas and comments heard by Ecology.

Proposed Removal from the Hazardous Sites List

in Kent, King County. Ecology has determined that this site does not pose a threat to human health or the

environment and proposes removing the site from the Hazardous Sites List.

### Public comment period: 11/7/05 – 12/8/05

Consent Decree Amendment and Restrictive Covenant

Ecology is asking for public comment on a consent decree amendment and restrictive covenant for a site known as Parcel 3, Site 5. The site is part of a larger mixed-use redevelopment project along the western shore of Thea Foss Waterway, Tacoma. The site is located at the 1500 block of Dock Street.

In 1994, Ecology entered into an areawide consent decree with the City of Tacoma and Tacoma Metropolitan Park District to clean up abandoned industrial and commercial properties along Dock Street. The consent decree has been amended several times since 1994 to address cleanup of specific parcels, add or remove potentially liable parties, and put in place restrictive covenants for certain properties.

Thea Foss Holdings LLC recently purchased Parcel 3, Site 5. As the new owner, Thea Foss Holdings LLC is liable for clean up of the site along with past owners. The amendment to the consent decree formalizes this responsibility, and adds Thea Foss Holdings LLC to the existing consent decree between Ecology and the City of Tacoma and Foss Waterway Development Authority.

Ecology and the potentially liable parties intend to restrict future activities on Parcel 3, Site 5, regardless of who owns the site. Ecology and potentially liable parties propose attaching a restrictive covenant to the consent decree amendment. The proposed restrictive covenant will:

- Restrict activities that may interfere with cleanup actions.
- Restrict groundwater use.
- Provide for monitoring well maintenance.
- Require owners to notify Ecology of ownership changes.

Future changes to the restrictive covenant will require Ecology's approval.

Interim Cleanup Action Proposed

The Shaub-Ellison parcel is the current location of the Pacific Gateway Plaza entrance to the University of Washington

Tacoma (UWT) campus at 1902 Pacific Avenue in Tacoma. It is south of the University Bookstore and across Pacific Avenue from the Washington State History Museum.

Four underground storage tanks; a vehicle hoist; a lube pit and floor drain,

and a tire manufacturing, sales and installation store that were demolished in the early 1990s, had formerly occupied this parcel.

Soil and groundwater at this location is currently contaminated with petroleum hydrocarbons.

The proposed interim cleanup action will use bioventing to treat petroleum-contaminated soils, and insitu aerobic treatment and monitored natural attenuation to treat petroleum-contaminated groundwater.

The University will also take various other measures to ensure that UWT employees, contractors and the public will not be exposed to residual petroleum contamination in soil or groundwater.

A draft interim cleanup action plan (ICAP) has been prepared in accordance with the Model Toxics Control Act.
The draft ICAP describes the extent of petroleum contaminated soils and

groundwater being addressed and the interim cleanup action being proposed by Ecology.

Former Scott Paper Mill - Port of Anacortes property, Q Avenue and 17th Street, Anacortes

### Public comment period: 11/10/05 - 12/9/05

Draft Interim Action Work Plan

Ecology is seeking public comment on a proposed Interim Action Work Plan to excavate contaminated soil and install new underground storage tanks at

Seafarers' Memorial Park. This site is located at the northern portion of the former Scott Paper Mill site in Anacortes, Washington. The proposed work will reduce the threat of further exposure to or migration of contaminated materials at the fuel tank, piping and dock abutment location, and protect human health and the environment.

The Scott Paper Company and other former owners operated lumber mills and a pulp mill at the site from approximately 1925 until 1978.

In 1979, the Port of Anacortes purchased the northern portion of the former mill site from the Scott Paper Company. Pulp milling and other operations at the site resulted in contamination in soil, ground water, and sediments. The contaminants of concern include: petroleum; carcinogenic polynuclear aromatic hydrocarbons (cPAHs); dioxins/furans; metals; polychlorinated biphenyls (PCBs); and deleterious substances (e.g., wood), brick, metals, and slag in the marine environment.

This interim action, which is scheduled to begin this fall, will be conducted under the existing consent decree for the northern portion of the site. The proposed actions include:

- Removal of a portion of the existing asphalt- pavement west of the Seafarers' Memorial Park building.
- Excavation and disposal of contaminated soil and wood debris to an offsite facility.
- Dewatering, treatment and discharge of extracted groundwater.
- Installation of two 15,000-gallon underground storage tanks within a concrete fuel tank yault.
- Installation of a fuel line and a dock abutment.
- Backfilling of excavated areas and restoration of paved and unpaved areas.

Agreed Order for Remedial Investigation/ Feasibility Study

Ecology seeks public comment on an Agreed Order for the Hytec Littlerock site, located at 13434 SW Halo-Kuntux Lane, Thurston County. The site is a former disposal pit/landfill for fiberglass manufacturing waste and is being investigated and cleaned up under the state's Model Toxics Cleanup Act (MTCA, Chapter 70.105D RCW).

Based on a site hazard assessment, Ecology has placed the site on the state's hazardous sites list. The site is ranked "four" on a scale of five, with one representing the highest relative risk compared to other sites.

Ecology contracted with Science Application International Corporation to study the property. The study looked at both soil and groundwater and found chemicals that may be harmful to human and environmental health. Science Application International Corporation also did a magnetic survey of the property, and found there might be metal drums or metallic material buried on site. Scientists have also seen a few unburied drums on the property. These results show that the site requires further study before cleanup can occur.

Ecology is entering into an Agreed Order with Chauncey & Elizabeth Lufkin and Hytec Inc. The agreement requires a

remedial investigation/feasibility study (RI/FS) of soil and groundwater contamination at the site. The RI/FS will seek to identify the locations of solid waste, metallic drums and objects that have been landfilled.

After review, Ecology sends a letter to the property owner stating either that additional work is required to be removed from the list of hazardous waste sites or that no further action is needed.
