What is the Law?

The law states that even where burning is permitted, everyone should try to reduce burning to the greatest extent possible.



Why?

Even unprocessed natural vegetation such as lawn clippings, leaves and pine needles produce **air pollutants** when burned. This includes **carbon monoxide** and **fine particulates** which, when inhaled into the lungs, can have serious health impacts.

Children, the elderly and those suffering from chronic respiratory conditions such as **asthma**, **emphysema and bronchitis** are the most vulnerable to poor air quality. Reducing air pollution is one way Ecology is working to decrease toxics in the environment.

What can I burn?

- No open burning is allowed inside the city limits of Clarkston. For all other areas, burning is allowed as long as you follow the county regulations.
- Recreational fires are allowed, such as campfires and barbeques, unless a county-wide burn ban has been issued.
 If allowed, only burn briquettes, propane, and bare, untreated, dry firewood.
- Yard and garden debris burning should be in piles no larger than 4'x4'x3'. If you are burning large debris or in piles larger than 4'x4'x3', you must apply for a burn permit from the Department of Ecology.

When can I burn?

Outside of Clarkston city limits, open burning is permitted but only at certain times of the year and within certain hours. Please visit the Asotin County website at www.co.asotin.wa.us for more information on the open burning policy.

What can't I burn?

- You may not dispose of yard debris in a recreational fire.
- Burning ANYTHING in a burn barrel, including natural vegetation, is illegal. This is because a barrel limits the amount of oxygen that can get to a fire, which results in incomplete combustion and lots of smoke.
- For a full list of prohibited items, please contact the Asotin County Building and Planning Department or Asotin County Fire District No. 1.

What happens if I burn when I'm not supposed to?

You can be **fined up to \$10,000** per day, per violation! Illegal outdoor burning is one of the most common air quality violations. It pays to know the rules before you burn!
