### Public comment period extended until 5/19/06

Proposed Prospective Purchaser Consent Decree

You're invited to comment on the Proposed Prospective Purchaser Consent Decree (Decree) for the Camp Bonneville Military Reservation site located east of Vancouver, Washington. The Decree outlines the process and schedule for cleanup so that the property can be transferred to Clark County and their contractors for cleanup and further investigation. After cleanup is completed the land will be redeveloped as a park and wilderness conservation area.

The Department of Defense owned and operated Camp Bonneville for firing range practice and training from 1910 to 1995. During that time, military ammunitions were stored and used at the site — including artillery ammunition, mortar ammunition, air-launched

rockets, shoulder-fired rockets, guided missiles, bombs, land mines (practice only), grenades, fuses, and small arms ammunition.

The camp was officially closed in 1995. Since then, investigations have been ongoing to characterize the contamination from the ammunitions and other hazardous substances and to develop a plan for re-using the site once it is cleaned up.

### **Public comment period:** 4/20/06 – 5/22/06

Proposed Consent Decree

Natural Resource Trustees and Hylebos Mediation Group

The Natural Resource Trustees for Commencement Bay (the State of Washington, the Puvallup Tribe of Indians, the Muckleshoot Indian Tribe, the National Oceanic and Atmospheric Administration of the United States Department of Commerce, and the United States Department of the Interior) have negotiated a settlement with a group of thirty-nine potentially responsible parties (the Hylebos Mediation Group) to compensate for natural resource damages on the Hylebos Waterway portion of the Commencement Bay-Nearshore Tideflats Superfund site. To settle their liability, the potentially responsible parties have agreed to complete construction of a restoration site near Orting, Washington

and pay assessment costs. A proposed consent decree has been prepared to formalize this settlement.

The Department of Ecology will receive, for a period of thirty-two (32) days (April 20, 2006 – May 22, 2006) comments relating to the proposed consent decree. Norwegian Salmon Industries, End of 140th Street NW, Gig Harbor

### Public comment period: 4/14/06 – 5/15/06

Removal from Hazardous Sites List Proposed

Ecology proposes to remove the Norwegian Salmon Industries site from the Hazardous Sites List. The site had sediment and soil contaminated with carcinogenic polynuclear aromatic hydrocarbons (PAHs), diesel, arsenic, and lead above cleanup standards. Groundwater was contaminated with PAHs, arsenic, lead, and chromium. In August 1997, the site was ranked on the Hazardous Sites List as a 1 (1 being high priority relative to other sites statewide; 5 being low). The site is vacant, except for a well house. Manson Construction Company reportedly stored heavy equipment on the site, and may have stored and treated timbers there as well. Manson Construction may have used slag material as fill on portions of the site.

This site is part of the governor's Puget Sound Initiative to restore the health of Puget Sound and Hood Canal by cleaning up toxic waste sites that leach pollutants into streams, groundwater, or stormwater. These tributaries eventually flow into Puget Sound and Hood Canal.

### **SPOKANE COUNTY**

River Front Properties (Kendall Yards), Summit Boulevard, Spokane

### Public comment period: 4/12/06 – 5/11/06

Proposed Removal From Hazardous Sites List

Ecology proposes to remove the River Front Properties (Kendall Yards) site from the Hazardous Sites List. The site was placed on Ecology's Hazardous Sites List because of contamination from previous land uses primarily related to the railroad industry. Union Pacific

operated a locomotive repair and servicing complex from 1914 to 1955 at the site. Other uses included a plating operation, storage facilities and and operation of several county facilities.

Contaminants in soil included petroleum product, metals and materials known as carcinogenic polyaromatic hydrocarbons (cPAHs).

The site covers 78 acres, divided into 14 parcels, and lies northwest of downtown Spokane, Spokane County, Washington. A small section of parcel 12 is not included in the site. The general site boundaries run from Summit Boulevard on the west to Monroe Street on the east. The site also includes land just north of the Spokane River from Ohio Avenue to Bridge Avenue. Some sections of the property extend north to College Avenue.

The cleanup was conducted in compliance with the U.S. Environmental Protection Agency's Brownfields Initiative and the Washington State Department of Ecology's Voluntary Cleanup Program. Ecology has reviewed independent cleanup reports and supporting documentation about the site cleanup. The work that has been completed sufficiently meets state cleanup requirements. Ecology has issued a letter to the property owner that states no further action is needed at the site.

Ecology will review all comments received during the 30-day comment period and prepare a response. The response, called a Responsiveness Summary, will be sent to those who submit comments. The summary will also be available at Ecology's Spokane office. Based upon the responses, Ecology may revise the decision to remove the site from the Hazardous Sites List, if justified.

### INDEPENDENT CLEANUPS

A property owner may conduct an independent cleanup of contamination and submit reports to Ecology. When a property owner applies to Ecology for review of their independent cleanup, the site enters the Voluntary Cleanup Program. After review, Ecology sends a letter to the property owner stating either that additional work is required to be removed from the list of hazardous waste sites or that no further action is needed.

# OTHER DEPARTMENT NOTICES

Update on the Restructuring of the Voluntary Cleanup Program (VCP)

On April 1, 2006 Ecology sent out notices to begin the process of Identifying and Terminating all Inactive sites in the VCP as part of our migration to the new SYSTEM and these sites were given 30 days to respond. A total of 398 VCP sites were identified in the program as not having had any activities in the past 12 months. As part of the migration process, these sites will either be terminated from the VCP or reactivated for migration into the new SYSTEM. On May 1, 2006 Ecology began sending out termination notices and processing the refunds of the \$500 deposits to those eligible VCP sites. The terminated sites may reapply in the future when they are ready to pursue an active cleanup under the VCP.

Beginning May 1, 2006, Ecology started returning deposits that were received

with applications. Effective June 1, 2006, the Program will be transitioning to a NEW automated billing system. Under the NEW system, Ecology will bill after service is provided instead of seeking pre-payment or deposits from VCP applicants. On July 1, 2006, the NEW billing system will be operational with billable charges for July being mailed to clients in early August. After that, VCP clients can expect a regular, 30-day billing, following the end of each month.

More information about billing statements will be available on Ecology's website in June. In addition, a notice on the billing process will be provided to all VCP clients with active accounts, known to Program staff. We apologize for any inconvenience during our transition to the NEW billing system. Your patience during the migration is greatly appreciated.
