Availability of RI/FS Reports and Draft and Final Cleanup Plans

A draft Remedial Investigation report (RI) for the uplands environment of the Rayonier Port Angeles Mill is available for public review and comment. The RI describes the nature and extent of contamination for the site. The site has dioxins, polycyclic aromatic hydrocarbons, petroleum and metals in soil and groundwater. Rayonier operated a specialty pulp mill on this property from the 1930s to 1997.

Pope and Talbot Sawmill Facility (Port Gamble Site), Port Gamble

Public comment period: 11/6/06 – 12/6/06

Draft Interim Action and SEPA determination Available for Public Review and Comment

The Pope and Talbot (P&T) Sawmill Facility is located on the Hood Canal in Port Gamble. The former mill facility consists of upland properties previously owned by P&T and is adjacent to Dept. of Natural Resource managed aquatic land.

P&T conducted sawmill and related forest product manufacturing operations at the site from 1853 to 1995. P&T transferred ownership to Pope Resource Inc. in 1985. Portions of the site are currently leased to Caicos for log sorting and material handing. Environmental investigations begun in 1999 confirmed the presence of wood debris in near shore sediments. This wood debris is harmful to the near shore habitat and will require cleanup.

The purpose of the interim cleanup is to remove the greatest remaining accumulations of wood debris from the marine environment and restore sediment associated habitat functions within this portion of Port Gamble Bay. Final cleanup actions to address remaining areas at the site will be developed following completion of this interim remedial action.

Pantorium Cleaners, 10 East Rose Street, Walla Walla

Public comment period: 11/29/06 – 12/29/06

Proposed Removal from Hazardous Sites List

Ecology proposes to remove the Pantorium Cleaners site from the Hazardous Sites List. Contaminated sites throughout the state are ranked on a scale of one to five. A rank of one represents the greatest potential threat to human health and the environment; five represents the least potential threat. This site ranked a three because of the amount of petroleum and solvents found in soil.

Dry cleaning and fabric dying businesses formerly operated at the site. These businesses used petroleum and solvents and stored them in underground storage tanks. The tanks leaked causing soil contamination. Cleanup crews removed nearly 261 tons of contaminated soil from the Pantorium Cleaners site and took it to the Finley Buttes landfill.

The Pantorium Cleaners site now meets Ecology's cleanup criteria and may be removed from the Hazardous Sites List based on the following:

- Review of independent cleanup reports submitted to Ecology.
- Supporting documentation.
- Work completed sufficiently meets state cleanup requirements.

Ecology also issued a letter to the property owner stating no further action is needed at the site. A restrictive covenant previously placed on the property will be removed at the end of the 30-day comment period.

INDEPENDENT CLEANUPS

A property owner may conduct an independent cleanup of contamination and submit reports to Ecology. When a property owner applies to Ecology for review of their independent cleanup, the site enters the Voluntary Cleanup Program. After review, Ecology sends a letter to the property owner stating either that additional work is required to be removed from the list of hazardous waste sites or that no further action is needed.
