Proposed Funding for Water Quality Improvement and Protection Projects

from Ecology's Water Quality Program

Fiscal Year 2007 Draft Offer and Applicant List and Fiscal Year 2007 State Revolving Fund Draft Intended Use Plan

The Washington State Department of Ecology (Ecology) invites you to attend a public meeting to discuss the Draft Offer and Applicant List for the Centennial Clean Water Fund, the federal Clean Water Act Section 319 Nonpoint Source Fund, and the Washington State Water Pollution Control Revolving Fund for state fiscal year 2007 (FY 2007) and the FY 2007 Washington State Water Pollution Control Revolving Fund Draft Intended Use Plan. Ecology welcomes your comments on the draft lists.

Ecology proposes to award approximately \$21.4 million from the Centennial Clean Water Fund, \$1.9 million from the Clean Water Act Section 319 Nonpoint Source Fund, and \$76.8 million from the Washington State Water Pollution Control Revolving Fund to fund 48 activity and facility projects during the FY 2007 funding cycle. These awards are based on directives and appropriations from the Washington State Legislature. The proposed projects will help improve and protect water quality for human health, aquatic life, fish habitat, recreation, and other important uses.

Driving Directions to the Pierce County Library Administrative Service Center (PAC):

From I-5: Take exit 127 east – Hwy 512, Puyallup. Go about 3.5 miles and take Portland Avenue exit right (south) to 112^{th} Street. Go left on 112^{th} about $\frac{1}{2}$ mile to Waller Road. The PAC building is just past the intersection on the left.

From Hwy. 410: Take Hwy. 167 west at Sumner about ½ mile to the exit for Hwy. 161 and Hwy. 512. Stay on 512 west to Canyon Road. Go left (south) on Canyon to 112th Street. Go right on 112th about 1.5 miles to the PAC building on right.
