### Proposal to Remove Site from Ecology's Hazardous Sites List

The Washington State Department of Ecology (Ecology) proposes to remove the Chapman Property (Site) from the State's Hazardous Sites List. Now that this Site meets cleanup guidelines and recommendations, we encourage your comments on the proposed delisting through May 30, 2007.

#### Site Background

The Chapman Property Site is located at 14167 Madrona Road SW, Port Orchard, WA, in a rural area and was used as an unlicensed auto repair shop.

An initial investigation by the Bremerton Kitsap County Health Department and Ecology in 1997 found poor housekeeping practices and soil contamination. The major structure on the Site, a barn, burned down between 1997 and 2005. The property is currently vacant and is to become a single-family residence.

There are two wells on the Site, a hand-dug well, with slow recovery water at 15 feet, and a drilled well with good flowing water at 25 feet. A branch of Burley Creek runs through the property. The property also has a small marsh associated with the creek.

As a result of activities on this property, the soil was contaminated with metals (lead and cadmium) and petroleum hydrocarbons and semi volatile organics (dimethyl phthalate, diethyl phthalate, 4- nitroaniline, pheneanthrene, and fluoranthrene) both in the soil and groundwater (potentially affecting the nearby surface water

marsh area). The Site was ranked "2" on the list. A rank of "1" represents the highest level of risk compared to other sites. The rank of "5" represents the lowest risk level.

#### Cleanup work at this Site

Cleanup work took place between 1998 and 2005 by excavation and off-site disposal of the contaminated soils.

Performance sampling of selected soil areas showed low levels of oil, chromium, and lead not exceeding Model Toxics Control Act (MTCA) Method A cleanup levels. Initial sampling of surface water (marsh) and well water were non-detect for the metals, gasoline, diesel, oil, benzene, toluene, ethylbenzene, and xylenes.

Confirmation sampling of both wells for volatile organics shows no threats to human health or the environment. .

Currently the owner intends to develop the Site to become a single-family residence.
