

# **EPP Standards and Certifications**

Standards and certification programs are helpful tools for identifying environmentally preferable products. Writing bid documents for environmentally preferable products can be simplified greatly by incorporating specifications from these programs.



**Safer Choice** is a U.S. EPA program that helps buyers identify cleaning and other products that perform well, are cost-effective, and are safer for the environment. http://www2.epa.gov/saferchoice

# **EPP-Related Laws and Directives**

RCW 39.26.160 Procurement of Goods and Services states that in determining the lowest responsive and responsible bidder, an agency may consider best value criteria, including whether the bid considers human health and environmental impacts.

RCW 39.26.280 Procurement of Goods and Services states that the Department of Enterprise Services shall establish policies that provide a preference for products and products in packaging that does not contain polychlorinated biphenyls.
