Interim Remedial Action and SEPA Determination of Non-Significance

The Washington State Department of Ecology (Ecology) is providing an opportunity for the public to comment on the Interim Remedial Action Plan and the issuance of a Determination of Non-Significance (DNS) for the soil cleanup at Peshastin/Dryden Elementary School, Ecology Facility/Site ID # 18617191, in Chelan County, Washington. Peshastin/Dryden Elementary School is located at 10001 School Street in Peshastin, Washington.

Site History

Soil beneath the grass on the playground at the school is contaminated with lead and arsenic. The contamination likely comes from the use of these chemicals as orchard pest sprays in the early and mid 20th century.

Sampling

Sampling and analysis indicate that contamination exceeds state cleanup levels for lead and arsenic. Ecology has considered several alternatives for cleanup.

Cleanup Action

The alternative preferred by Ecology consists primarily of placing clean soil on top of the existing soil, and establishing new grass on this clean soil. Ecology has determined that this alternative will provide the necessary barrier to prevent human exposure to the contaminants. The plan includes modification of the existing irrigation system to maintain the turf grass cover.

Determination of Non-Significance

After reviewing the State Environmental Policy Act (SEPA) environmental checklist, Ecology has determined that the cleanup action will not have a probable significant adverse impact on the environment and an Environmental Impact Statement (EIS) is not required. The checklist may be reviewed at the locations listed in the information box on the right.

Documents relating to the cleanup are available for public review. A public comment period will run from April 16, 2008 through May 16, 2008.
