Five-Year Review Completed

Ecology has prepared this notice to provide you with information about the 5-year periodic review of cleanup actions conducted at the Lowes HIW 152 Property (Site). You are welcome and encouraged to comment on the report describing this review during the comment period which extends from May 29, 2008 through June 30, 2008.

The Lowes HIW 152 Site is located in the City of Wenatchee, Chelan County, Washington. Soil sampling was conducted in 1997 as part of an independent remedial action. Soil samples indicated the presence of lead, arsenic, DDT, DDE, DDD, and Dieldrin at concentrations exceeding MTCA Method A cleanup levels.

Protective capping was selected as the remedial action for the Site. Several inches of crushed rock sub-grade capped by asphalt were used to cover the majority of the site that does not fall under the building footprint. In areas where soil was to remain exposed due to landscaping, native soils were excavated to a depth of 36 inches and used as backfill under impervious surfaces elsewhere on the site. Following remedial activities, a restrictive covenant was recorded for the property and the Site received a No Further Action determination.

Reviews are conducted every 5 years by Ecology for sites that have Environmental Covenants and/or Institutional Controls. The review is intended to examine the effectiveness of cleanup activities and and to assure the continued protection of human health and the environment.

The asphalt and clean soil cap remain on the Site. Based upon the site visit conducted on May 2, 2008, no repair, maintenance, or contingency actions have been required. The Restrictive Covenant for the Site was recorded and is in place. This Restrictive Covenant continues to prohibit activities that will result in the release of contaminants contained as part of the cleanup activities.

Soils with residual pesticide concentrations higher than Method A cleanup levels are still present. However, the asphalt cap and the clean soil cap continue to prevent human exposure to residual pesticides by ingestion and direct contact with soils. The Restrictive Covenant for the property ensures that the integrity of the cap will be protected through maintaining the current use of the Site.

Once the public comment period ends, Ecology will review all comments received and will make recommendations for any suggested changes. If no significant changes are made, the review will be finalized. If significant changes are made to the document, an additional public comment period will be held. In addition, you may provide us with relevant information to the 5-year review. Please report any questions you have or unusual activities taking place at the Site.

### Rayonier Mill Off-Property Soil Dioxin Study, Port Angeles

## Public comment period: 6/30/08 - 7/30/08

Draft Soil Sampling Plan Available for Public Comment Public Meeting July 9, 2008

Ecology is planning a study to look at whether dioxins were deposited in surface soils downwind of the former Rayonier Mill in Port Angeles. Past soil testing in the community near the mill has found very low levels of dioxins. However, it is currently unknown if those levels are associated with the former mill, some other sources, or simply background levels.

This study will focus on areas in Port Angeles that are downwind of the former Rayonier Mill site where dioxins might have been deposited in the past. Ecology will try to determine

- The magnitude of dioxin soil contamination in the areas identified as "downwind" of the Rayonier site.
- The former Rayonier Mill's contribution to measured dioxin contamination, compared to other possible sources.

Specific sample locations have not yet been chosen. Ecology will need help from local property owners with accessing the sampling locations.

Some property owners will be contacted for permission to sample their soils. Final sample locations will be chosen after the end of the comment period and will be based on public input, historical data and ability to gain access to property in the study area.

The Department of Ecology is hosting a public meeting to discuss the study and the draft Soil Sampling Plan on July 9 at the Olympic Medical Center located at 939 Caroline St. in Linkletter Hall. The meeting will begin at 6:30 pm and a presentation will be given at 7 pm. The public is also invited to a technical workshop on the Soil Sampling Plan from 3-5 pm in the Wendel Room.

Completion of Negotiations for an Agreed Order/Consent Decree

Ecology and Fuel Processors Inc., have negotiated an agreed order to conduct a remedial investigation at the Fuel Processors Site in Woodland, WA. The Site is an old wholesale petroleum plant which was used as an oil recycling and oil transfer facility. The owner plans to close the facility. However, if contamination is detected above regulatory limits, a feasibility study will be conducted and a cleanup action plan written to implement a chosen remedy at the site. The negotiations began on September 17, 2007 and ended on May 2, 2008. The focus of the agreed order is to determine if soil and ground water at the site may be contaminated with petroleum hydrocarbons.

Agreed Order

An Agreed Order and associated Public Participation Plan for the Pope & Talbot, Inc. Sawmill site in Port Gamble are available for public comment. The Agreed Order requires Pope Resources LP and Olympic Property Group LLC to conduct a Remedial Investigation and

Feasibility Study (RI/FS) and to develop a Public Participation Plan and draft Cleanup Action Plan for the site.

The Pope & Talbot, Inc. Sawmill was a forest products manufacturing facility for approximately 142 years (1853 to 1995).

Upland manufacturing activities resulted in the release of hazardous substances, including petroleum hydrocarbons, carcinogenic polycyclic aromatic hydrocarbons, and metals. Some of this contamination has been found in soil and groundwater. Log rafting and chip loading operations deposited wood debris on the bed of Port Gamble Bay. Wood debris smothers near-shore aquatic habitat and causes changes in water quality.

Between 2002 and 2007, Ecology and the companies removed approximately 26,000 tons of soil and 31,000 cubic yards of wood debris from the site.

#### Oakland Bay Sediment Investigation, Shelton

### Public comment period: 6/2/08 - 7/2/08

Draft Sampling and Analysis Plan Available for Public Comment

Public Meeting: June 16, 2008

Ecology is planning a study of pollution in the sediments of Oakland Bay. Historical industrial and commercial use of the Bay has led to contamination of sediments. Past sediment sampling has shown levels of toxic chemicals present above state cleanup standards including polycyclic aromatic hydrocarbons (PAHs), wood waste compounds, metals and tributyltin.

The goals of the Sediments Investigation are to:

- Determine the nature and extent of potential sediment contamination and wood waste throughout Oakland Bay.
- Conduct a survey to determine the distribution of wood waste.
- If present, attempt to determine the potential source(s) of dioxin, total petroleum hydrocarbons (TPH) and polycyclic aromatic hydrocarbon (PAH) contamination.
- Characterize the horizontal and vertical extent of contamination in sediment.
- Analyze sediments and shellfish for contaminants in order to evaluate potential risk to humans and the ecosystem.

As part of Governor Gregoire's Puget Sound Initiative, several areas in the south Sound have been identified as high priority cleanup areas for Ecology's Toxics Cleanup Program. Early actions in these areas will contribute significantly to the restoration of Puget Sound. The Oakland Bay is one of these early action areas and this investigation is being funded through the Puget Sound Initiative.

Consent Decrees to Implement Cleanup Action Plan Available for Public Review and Comment

Ecology and Murray Pacific Corp (Murray Pacific) are entering into a Consent Decree to continue cleaning up contamination at the B&L Woodwaste site, located along the border of Milton and Fife. This legal document requires Murray Pacific to implement the Cleanup Action Plan.

A second consent decree is proposed between Ecology, Wasser and Winters Company and the Louisiana Pacific Corporation (Louisiana Pacific), requiring partial funding for the cleanup. The Louisiana Pacific Consent Decree requires payment of \$1 million to help fund the implementation of the cleanup action plan.

The B& L Woodwaste landfill was used from mid 1970's until the early 1980's. Woodwaste mixed with soil and Asarco slag, originating from log sort yards in Commencement Bay were taken to this site for disposal. The Asarco slag leached arsenic into the soils groundwater.

Agreed Order and draft Cleanup Action Plan Available for Public Comment

Ecology would like your comments on the draft Cleanup Action Plan for the Eddon Boat Park site. Ecology is working with the City of Gig Harbor (City) to clean up the approximately three acre site. The land will later be developed as a public park.

The upland property and the inwater areas are contaminated with heavy metals, tributyltin, polycyclic aromatic hydrocarbons (PAHs), and polychlorinated biphenyls (PCBs). The City investigated soils, groundwater, and sediments at the site under a U.S. Environmental Protection Agency (EPA) Brownfields grant and with technical assistance from Ecology's Voluntary Cleanup Program (VCP). The City is now working with Ecology's formal cleanup program to plan site cleanup.

The draft Cleanup Action Plan includes

- Dredging contaminated sediments near the boatyard haul-out railway, pier, and dock.
- Capping less contaminated sediments.
- Removing a small area of contaminated soils north of the boathouse building.
- Removing treated timber bulkheads on the south part of the site.

Cleanup of contaminated sediments, soils and groundwater must meet state standards under the Model Toxics Control Act (MTCA), Chapter 70.105D.

Negotiations Begin for an Agreed Order

Negotiations began May 30, 2008 between Ecology and the Washington State Department of Corrections for an Agreed Order. The Order will require the Department of Corrections to conduct a Remedial Investigation and Feasibility Study at the Washington State Penitentiary site in Walla Walla. The Agreed Order is a legal document issued by Ecology. It formalizes the agreement between Ecology and the Department of Corrections for the necessary investigations at the site. It is anticipated negotiations for the Order will be complete in sixty days.

The Penitentiary used hazardous chemicals in its operations, through dry cleaning, machine repair, metalworking, furniture refinishing, and refueling activities. Currently, the chemicals of concern are volatile organic compounds (VOCs) and petroleum. The purpose of the Remedial Investigation is to gather more information to determine where and how much contamination is present in soil and groundwater. The Feasibility Study will evaluate cleanup alternatives in preparation for a cleanup action.
