Lake Union Air Parcel C Property



Investigation Completed and Determination of No Further Action

The Department of Ecology would like to update you on the Lake Union Air Parcel C Property (Parcel C) site. Parcel C is located at the south end of 950 Westlake Ave N Parcel C, Seattle, Washington.

Shannon & Wilson Inc. completed an environmental investigation in March 1999 at this property. The groundwater and sediment data collected show no contamination exceeding Model Toxics Control Act (MCTA) cleanup levels. A petroleum hydrocarbon ground water plume located off site has not reached Parcel C. Based on this information, Ecology has determined that the site does not pose a threat to human health or the environment.

Site Background

Parcel C is located on the southern extreme of the west shore of Lake Union along Westlake Avenue North.

In 1993, Ecology and the Committee for the Seattle Commons (Commons) signed a *De Minimis* Consent Decree ("De Minimis" means little or no contribution to the cause(s) of contamination at a property or site).

Commons was a non-profit Washington corporation that proposed to create a revitalized 470acre business and residential neighborhood in the South Lake Union area. Its intention in purchasing Parcel C was to hold the property for development as a public park by the City of Seattle or other public entity. However, Seattle residents did not approve the development proposal by Commons, and Commons later dissolved. City Investors X L.L.X/Vulcan NW Inc. is the current owner of Parcel C.

Studies Conducted

Commons hired Shannon & Wilson Inc. to perform an Environmental Assessment when they were interested in purchasing Parcel C. The assessment indicated one soil sample exceeded Model Toxics Control Act (MTCA) cleanup levels for petroleum hydrocarbons. In addition, one on-site sample revealed soil arsenic levels above state cleanup levels. The environmental firm also conducted a groundwater investigation of the area in and around Parcel C. The study found that an off-site contaminated groundwater plume is flowing toward Parcel C. The off-site groundwater plume has contamination including Volatile Organic Compounds (VOCs), metals, and Total Petroleum Hydrocarbons (TPH). A limited on-site sediment contamination study was also conducted. No sediment contamination related to the site activities was found.

Cleanup Activities

In the mid- to late 1980's, two underground storage tanks were reported removed from the site.

Over a two-year period (between 1994 and 1995), eight quarterly groundwater samples were taken from monitoring well (MW) MW-1. From 1997-1999, four additional semiannual groundwater samples were taken from monitoring well MW-1. The results indicate the off-site VOC contamination probably has not reached Parcel C.
