The Washington Department of Ecology (Ecology) invites you to attend a public meeting to discuss the Water Quality Draft Offer and Applicant List for the Centennial Clean Water Fund, the federal Clean Water Act Section 319 Nonpoint Source Fund, and the Washington State Water Pollution Control Revolving Fund for state fiscal year 2009 (FY 2009). Ecology will also discuss the FY 2009 Washington State Water Pollution Control Revolving Fund Draft Intended Use Plan.

Ecology proposes to award approximately \$18.3 million in funds from the Centennial Clean Water Program; \$1.9 million from the Clean Water Act Section 319 Nonpoint Source Fund; and \$52.2 million from the Washington State Water Pollution Control Revolving Fund to fund approximately 32 activity and facility projects during the FY 2009 funding cycle. The proposed projects will help improve and protect water quality for human health, aquatic life, fish habitat, recreation, and other important uses.
