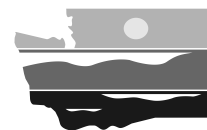

### CLALLAM COUNTY

**Sunnydell Dryke Shooting Range, 292 Dryke Road, Sequim Facility Site ID# 1283666**

**Public comment period:  
7/6/09 – 8/5/09**

*Agreed Order for Investigation of Contamination*

Sunnydell Dryke Shooting Range is being investigated for lead contamination and will be cleaned up. Ecology is entering into an Agreed Order with owners Chuck Dryke and Rosemary Knotek. Under this agreement, they will complete a Remedial Investigation to determine the nature and extent of contamination. They will also do a Feasibility Study to look at possible cleanup options. Ecology will then write a Cleanup Action Plan that describes the selected cleanup remedy.

Sunnydell Dryke Shooting Range is located at 292 Dryke Road in Sequim. In 2004, Clallam County Department of Health & Human Services took water and sediment samples from two ponds on the property after receiving a complaint about water coming onto a neighbor's property. Samples had high levels of lead, which is a common contaminant at shooting ranges. The site was placed on the state's Hazardous Sites List in 2006.

**Camp Bonneville Military Reservation, Proebstel Facility Site ID# 5093080**

**Public comment period:  
6/8/09 – 7/8/09**

A Draft Cleanup Action Plan (CAP) and proposed State Environmental Policy Act (SEPA) Determination of Non-Significance for Camp Bonneville's sitewide Remedial Action Unit 3 (RAU 3) are available for public review and comment. The draft CAP describes details and next steps for cleanup within each of the RAU 3 Remedial Work Areas and includes munitions of explosive concern (MEC) and munitions debris findings to date; accessibility, reuse, and hazard ranking considerations; cleanup action evaluation and selection; and the recommended cleanup action(s).

Department of Defense owned and operated Camp Bonneville for firing range practice/training from 1910 -1995. During that time, military ammunitions were stored or used at the site. Investigations to characterize site-wide contamination have identified

unexploded ordnance, explosive compounds, lead, petroleum products, pesticides and volatile organic compounds in the soil, and perchlorate and explosive chemicals in the groundwater.

Camp Bonneville is located in Clark County, approximately five miles from Vancouver city limits. Ecology will determine when the facility meets state cleanup requirements, after which point, ownership will be transferred to Clark County for use as a park and wilderness conservation area.

**All City Wrecking, 9438 Des Moines Way South, Seattle (former address) Facility Site ID# 22342251**

### Public comment period: 7/2/09 – 8/3/09

#### *Periodic Review Completed*

Ecology invites you to review and comment on a document called a periodic review for the All City Wrecking Site (Site). A periodic review is conducted at least every five years after the initiation of a cleanup action at a site, as required by the Model Toxics Control Act (MTCA). The purposes of the review are to evaluate site conditions, after cleanup is considered complete, and to ensure protection of human health and the environment.

The All City Wrecking property is located in the City of Seattle, King County, Washington. The Site, known as the former All City Wrecking (aka All City Auto Wrecking and All City Auto) property, was located off of State Highway 599 in South Park, at 9438 Des Moines Way South in King County, Washington. Currently, there are two addresses for the Site, 9510 14th Avenue South, and 9525 14th Avenue South. The Site has been operating as an auto wrecking yard for the last 35 years. Today, the Site is used for a gasoline/mini-mart station on the western parcel, and a smaller auto wrecking business on the eastern parcel. Except for the perimeter landscaping and grassy swale, the majority of the two parcels are paved or covered with concrete surfaces and foundations. It was determined as a result of all the investigations that the historical auto wrecking and storage activities at the Site resulted in the limited release of petroleum hydrocarbons and lead into surface soil. Releases were primarily due to used oil from engine and wrecked-car storage and handling. Total petroleum hydrocarbons quantified as diesel, and lube oil (heavy oil) existed in limited areas on the Site in excess of Ecology's Method B residential cleanup level of 7,000 mg/kg (determined using Ecology's Interim TPH Policy). Lead also existed in limited areas on the Site in excess of Ecology's Model Toxics Control Act

(MTCA) Method A industrial cleanup level of 1,000 mg/kg. The owners of the property performed limited soil excavation, treatment, and confirmation soil sampling of the contaminated soil that exceeded site cleanup levels. Site groundwater monitored from four on-site wells did not contain concentrations of constituents of concern in excess of groundwater concentrations in the surrounding, upgradient vicinity. Therefore, no groundwater remedial action was performed for the project site. A restrictive covenant was recorded in June 1999, and a 'No Further Action' letter was issued by Ecology June 24, 1999.

#### Results of the Periodic Review:

- Some petroleum contaminated soils remain on-site;
- The asphalt cap continues to prevent human exposure to contamination by methods of ingestion and direct contact with soils;
- The Restrictive Covenant on the property protects the cap;
- Based upon the site visit conducted on January 28, 2009, no repair, maintenance, or contingency actions have been required;
- It's recommended that the 'No Further Action' letter be replaced since it incorrectly addressed the arsenic in the groundwater, which is apparently from an off-site source.

Ecology will review comments received during the comment period and make recommendations for suggested changes. The periodic review will become final if no significant changes are made. An additional public comment period will be held if significant changes are made.

*Draft Agreed Order and Public Participation Plan Available for Public Review and Comment*

Ecology requests your comments on two documents: The Agreed Order and the Public Participation Plan. The documents are for the proposed cleanup of contamination at the Glacier Northwest, Inc.-Reichhold, Inc. site.

On May 14, 2009, Reichhold, Inc. and Glacier Northwest, Inc. signed a draft Agreed Order to conduct a remedial investigation/feasibility study (RI/FS) and submit a draft cleanup action plan (dCAP). The purpose of the remedial investigation is to determine the extent of hazardous substances in soil, groundwater, surface water and sediments at the site. Information and data obtained during the RI phase of this study will be used to support the evaluation and selection of cleanup solutions for this site.

The draft Public Participation Plan is available for review. It explains how Ecology will keep the community involved during the cleanup process. The plan outlines and describes the tools and approaches that Ecology will use and provides information for the community.

The purpose of the Agreed Order is to protect human health and the

environment. It ensures that the cleanup happens in a timely manner according to Washington State’s cleanup law, the Model Toxics Control Act.

Initial sampling found metals and phenols including pentachlorophenol in soil; pentachlorophenol and arsenic in groundwater; dioxins in sediment; and arsenic in surface water seeps.

The Glacier Northwest, Inc.-Reichhold, Inc. site (site) is generally located at 5900 W. Marginal Way SW in Seattle, Washington. It is bordered to the north by Duwamish Shipyard, to the east by the Lower Duwamish Waterway, to the south by Terminal 115, and to the west by West Marginal Way SW.

Glacier Northwest, Inc. currently owns the property that was formerly operated by Reichhold, Inc., a chemical product manufacturer and distributor. This property has had a variety of past industrial operations and uses.

**Kent Highlands Landfill, 23076 Military Road South, Kent Facility Site ID# 2042**

### *Periodic Review Completed*

Ecology invites your comments on a document called a periodic review for the Kent Highlands Landfill site. A periodic review is conducted at least every five years after the initiation of a cleanup action at a site, as required by the Model Toxics Control Act (MTCA). The purposes of the review are to evaluate site conditions, after cleanup is implemented, and to ensure protection of human health and the environment.

The Kent Highlands Landfill property is situated on the eastern flank of the Des Moines upland, where it adjoins the Green River valley. The landfill occupies a former natural ravine that extended about 2,500 feet from near the top of the upland down to the valley floor. The current fill surface slopes downward from a top elevation of 260 feet MSL to a base elevation of 35 feet MSL at the eastern toe of the landfill. The Seattle Solid Waste Utility started land filling operations at the Site in 1968. The landfill received mostly municipal garbage until 1983. The landfill also took in industrial wastes and construction debris after 1983. Disposal operations ceased on December 31, 1986. The City of Seattle was in the process of completing a closure plan at that time.

The Landfill has been subject to federal, state, and local agency regulation since its inception. It initially operated under a “Nonconforming Permit” from the Seattle-King County Department of Public Health, and Ecology imposed leachate collection and treatment requirements in 1974. No specific regulatory actions were taken with regard to landfill gas in the early years, although there were complaints of odors coming from the landfill. Gas migration was first measured directly in 1984 in gas probes installed west of the landfill. A gas monitoring program was finally initiated in 1988 at the request of the Washington State Department of Health.

Ecology conducted a Potential Hazardous Waste Site Preliminary Assessment in 1984. Based on this assessment, the



Site was proposed for listing as a Superfund site. The EPA performed a preliminary assessment under its hazard ranking system, and performed a subsequent evaluation in 1990. The site was placed on the NPL on August 30, 1990, because of the presence of an unknown quantity of hazardous waste at the site. Recognizing their responsibility to conduct the investigations necessary to close the landfill, the City of Seattle entered into a Consent Order with Ecology that called for the City to conduct a remedial response program in a manner consistent with the National Contingency Plan, beginning with a remedial investigation.

Contamination was found in the Sand Aquifer and in the Recent Alluvium Aquifer. Leachate in the landfill discharges primarily to the Sand Aquifer, which in turn discharges to the Recent Alluvium Aquifer. The Recent Alluvium Aquifer is in hydraulic connection with the Green River. Surface water in Midway Creek was found to be degraded by the landfill; no effects of the landfill on the water quality of the Green River were observed. Based on the results of the remedial investigation and further work, ground water monitoring at the site is being done for field parameters, conventional chemical parameters, dissolved metals, volatile organic compounds, herbicides, and pesticides.

Results of the Periodic Review:

- The cover and controls continue to prevent human exposure to contamination by methods of ingestion and direct contact with soils, and isolates and contains the hazardous substances.
- The Restrictive Covenant and Consent Agreement on the property protect the cover and controls.
- Based upon the site visit conducted on June 17, 2009, requirements are being met.

Ecology will review comments received during the comment period and make recommendations for suggested changes.

The periodic review will become final if no significant changes are made. An additional public comment period will be held if significant changes are made.

*Agreed Order*

*Public Meeting July 23, 2009 from 7:00 to 9:00 pm, Highline School District’s Educational Resource and Administration Center, 15675 Ambaum Blvd., S.W., Burien*

Ecology (Ecology) requests your comments on the Agreed Order (legal agreement) for the Lora Lake Apartments cleanup site.

In the 1940s and 1950s, the site was used for cleaning barrels that had contained chemicals. From about 1960 to 1981, the site was used for auto wrecking.

A developer purchased the site during the 1980s, and in 1987 built the Lora Lake Apartments. In 1998, the Port of Seattle (Port) bought the site, part of which was required for Sea-Tac Airport’s Third

Runway Protection Zone, where residences are prohibited. Six of the apartment buildings were within the Runway Protection Zone. These buildings were demolished in 2007. Sixteen buildings remain and are scheduled for demolition this summer. The portion of the site that was not required for the Runway Protection Zone is slated to be redeveloped.

Former activities at the site released hazardous chemicals into the environment including polycyclic aromatic hydrocarbons, petroleum products, pentachlorophenol, dioxin, tetrachloroethene, trichloroethene, 1,2-dichloroethane and arsenic. In June 2009, Ecology and the Port entered into the Agreed Order, under which the Port agrees to conduct a Remedial Investigation/Feasibility Study (RI/FS). The Remedial Investigation will identify the nature and extent of contamination associated with former operations at the site. The Feasibility Study will assess alternative means of cleaning up the contamination. A Work Plan will be prepared describing the investigations and engineering assessments that will be performed. When the work is complete, the Port will prepare a report presenting the results of the RI/FS.

A Public Participation Plan will be prepared that will describe how the public will be informed of work at the site and indicate specific opportunities for public input. The public will have an opportunity to comment on the Public Participation Plan, the Work Plan, and the RI/FS report before they are finalized.

*Agreed Order and Public Participation Plan*

Ecology invites public comment on the proposed Agreed Order and Public Participation Plan for the Plastic Sales & Service Inc Site (site). At this site, while the investigation is ongoing, the known potential chemicals of concern for soil, soil vapor, and groundwater are PCE, Trichloroethene, Cis-1,2-dichloroethene, Trans-1,2 dichloroethene, and Vinyl Chloride

Ecology and The Lutheran Retirement Home of Greater Seattle doing business as The Hearthstone Retirement Living (The Hearthstone), Plastic Sales & Service Inc, Karkrie LLC, and Ruben and Patricia Rael are entering into a legal agreement called an Agreed Order. Under this proposed Agreed Order, the Potentially Liable Party (PLPs) have agreed to take on lead responsibilities for certain actions, recognizing that

ultimately all PLPs are jointly and severally liable to Ecology for work at the Site. Plastic Sales & Service Inc, Karkrie LLC, and Ruben and Patricia Rael agree to lead the following actions:

- Complete Remedial Investigation/ Feasibility Study (RI/FS) report, which will present the results of the investigation and evaluate the cleanup alternatives.

Prepare a draft Cleanup Action Plan (CAP), which will use the RI/FS information to describe a preferred cleanup action.

Under this proposed Agreed Order, The Hearthstone Retirement Living agrees to lead the following actions:

- Prepare an Interim Action Work Plan.
- Conduct an Interim Cleanup Action at Former Laundry Building Property.

The draft Public Participation Plan outlines and describes the tools that Ecology will use to inform the public about site activities, and it identifies opportunities for the community to become involved in this process.

*Proposed Delisting from Hazardous Sites List*

Ecology plans to remove the Precision Pattern cleanup site from the Hazardous Sites List. This site was cleaned up under the Voluntary Cleanup Program (VCP). Under the VCP property owners can clean up their own property to meet the requirements of the Model Toxics Control Act (MTCA) with technical assistance from Ecology. Ecology has reviewed the site cleanup activity and determined that

- The site is no longer a threat to human health or the environment.
- The cleanup actions at the site meet MTCA cleanup standards.
- No further action is needed.

Precision Pattern has operated at 2620 East G Street for 39 years providing precision machining and steel and aluminum tooling and modeling. An underground storage tank containing heating oil leaked and released contamination to the soil and groundwater.

In 2005, the tank, 300 gallons of diesel inside the tank and 30 tons of contaminated soil were removed from the property. Soil and groundwater sampling after the cleanup work confirmed that contamination was below state standards and no further cleanup was needed.

The purposes of the review are to evaluate site conditions, after cleanup is considered complete, and to ensure protection of human health and the environment. Because the new information pertains to past sampling data which will need to be studied, and because additional sampling will occur at an adjacent property this summer, the periodic review must be delayed until all the data is available. A new draft periodic report will be written and finalized after an additional public comment period, if no significant new information is received at that time.

The 3205 V Place Site is located in the City of Anacortes in Skagit County, Washington. Environmental studies at the site were initiated in January 1997 with a Phase I Environmental Site Assessment (ESA). Significant concentrations of hydrocarbons in the diesel to heavy oil range were found in shallow soils near the Hardboard Plant; a building located off site but adjacent to the western property boundary of the subject site.

Excavation and disposal was selected as the cleanup action for the Site. The objective was to remove and dispose of the soils exhibiting greater than 15,000 mg/kg TPH. Soils in three areas of the site that were found to exceed the 15,000 mg/kg concentration during the previous site investigation were removed during the cleanup action. A total of 1,939 tons of soil was transported and disposed of at the Olympic View Sanitary Landfill in Bremerton, Washington.

Several exceedances of the TPH cleanup level remain on site; however, these areas are either at the southern property boundary or restricted by the presence of the property boundary and the Custom Plywood foundation structure on the west.

Because the residual contamination was located under a building and on an adjacent property, no additional remedial actions were conducted. A restrictive covenant was recorded for the property and the Site received a 'No Further Action' determination.

An Agreed Order and associated Public Participation Plan for the Hill's Chevron Site in Blaine, WA are available for public comment. The Agreed Order requires Chevron U.S.A., Inc. to conduct a Remedial Investigation and Feasibility Study (RI/FS) and to develop a Public Participation Plan and draft Cleanup Action Plan for the Site. The Hill's Chevron Site is a gas service station. Petroleum contamination has been found in soil and groundwater due to operations. Investigation results have found the following contaminants above state cleanup levels in soil and groundwater at the Site: total petroleum hydrocarbons (TPH), benzene, toluene, ethylbenzene, and xylene (BTEX).

Approximately 500 cubic yards of soil and 25,200 gallons of groundwater and "free product" (petroleum that is not dissolved in groundwater) were removed in 1989 and 1994, but further study of the entire Site is needed to fully characterize the contamination.
