Negotiations for an Agreed Order

Ecology and the current co-owners of the Caribou Realty Group site property have begun negotiations for an Agreed Order to complete a Remedial Investigation and Feasibility Study at the Caribou Realty site in Vancouver. Investigations of the property revealed that perchloroethylene, a solvent, was above MTCA cleanup levels in soil and groundwater. A portion of the building on the property housed a dry cleaning facility for an undetermined period of time prior to 1981. Soil and groundwater contamination occurred while the dry cleaning tenant was in operation.

Agreed Order for Remedial Investigation, Feasibility Study and Draft Cleanup Action Plan

Ecology and the Union Ridge Investment Co. are entering into an Agreed Order to begin investigating contamination found on and around a property in Ridgefield. The Agreed Order (legal document) requires Union Ridge Investment Co. to complete the following:

- A Remedial Investigation to define the full nature and extent of contamination. Interim actions (partial cleanup actions) may be taken if necessary to prevent the spread of contamination.
- A Feasibility Study to determine possible cleanup alternatives.
- A draft Cleanup Action Plan outlining the selected cleanup actions.

The Park Laundry property, located at 122 N. Main Avenue in Ridgefield, was used as a dry cleaner from approximately 1965 - 77 although the exact dates are not known. During that time, it is suspected that chemicals typically used during dry cleaner operations (volatile organic chemicals) were released to the environment. The property was purchased by Union Ridge Investment Co. in 1975.

Investigations to date have confirmed the presence of tetrachloroethene (PCE) above state cleanup standards in both soil and groundwater. It was also discovered that contamination in groundwater is migrating off property and onto adjacent properties to the north. Investigations done in 2002 and 2006 confirmed the presence of PCE and trichloroethene (TCE) in groundwater samples at two nearby properties.

In 2007, Ecology referred the property to the United States Environmental Protection Agency (USEPA) for additional investigations under the federal Superfund Program. In 2008, USEPA conducted a site investigation of the property. After confirming presence of contamination, the site was transferred back to the Department of Ecology for additional investigation and to expedite cleanup.

The property was evaluated by Ecology and has been given a Washington Ranking Method rank of "3" (on a scale of 1 to 5 where "1" represents the highest level of concern). It is now part of the formal cleanup program under the Model Toxics Control Act.

Agreed Order for Draft Cleanup Action Plan

Ecology and Lewis County are entering into an Agreed Order (legal agreement) to finish cleaning up contamination at the Lewis County Central Shop cleanup site. Lewis County is required to implement a Cleanup Action Plan which involves:

- Groundwater treatment to remove contamination.
- · Groundwater monitoring to evaluate

the effectiveness of treatment and natural breakdown of contaminants over time.

• Development of institutional controls which will prevent any installation of new wells near the contamination until cleanup levels are reached.

The Lewis County Central Shop is an active vehicle maintenance shop located at 109 Forest Napavine Road in a rural area 4 miles south of Chehalis. There are currently five buildings on the 4.4 -acre property.

Lewis County has used the property since the late 1950s for a variety of activities including general automotive repair and maintenance, equipment washing and storage. These activities resulted in the release of contamination to the site.

In 1998, during routine water testing, Lewis County found elevated levels of solvents (trichloroethene (TCE) and tetrachloroethene (PCE)) and several benzene compounds in the water supply for the property. Three chemicals were above federal standards for drinking water. In response, the County established a public water supply to the Shop.

The County Department of Health sampled 20 private wells near the property and found one private well (1,000 feet away) with TCE and PCE above federal drinking water standards. Lewis County established a public drinking water source to this home. In 2000, Ecology entered into an Agreed Order with the County and began investigating the nature and extent of contamination.

Since contamination was discovered, the County has taken several steps to reduce the level of contamination in groundwater and soil. However, some contamination remains on-site and offsite in groundwater. A Feasibility Study was done to examine possible cleanup alternatives. A cleanup remedy is now being proposed to continue treatment of contamination.

Agreed Order for Investigation and Cleanup Available for Public Comment

Ecology is entering into an Agreed Order with USG (formerly US Gypsum). Under this legal agreement, USG will investigate and clean up contamination at the USG Highway 99 site. The address is 7110 Pacific Highway East in Milton, but the cleanup site includes all areas affected by contamination. USG is agreeing to:

- Investigate the nature and extent of pollution at the site.
- Evaluate possible cleanup options; and

• Clean up the site to meet state standards under the Model Toxics Control Act.

This site is located on the banks of the Hylebos Creek, which flows into the Hylebos Waterway and into Commencement Bay. Before 1985, USG used the site for disposing of waste from their rock wool manufacturing plant in Tacoma. Slag from the former Tacoma Asarco smelter was used as raw material for the rock wool. The slag contained arsenic—a toxic metal. As a result, before 1973, waste from USG's Tacoma plant contained arsenic.

Public Comment Period for an Agreed Order for a draft Cleanup Action Plan and Investigation Reports

Ecology and the Port of Tacoma (Port) are entering into an Agreed Order (legal document) to continue efforts to clean up contamination at the Citifor site in Maytown. The Port of Tacoma purchased the 745-acre Citifor Inc site property in 2006. The site was used historically to manufacture and distribute dynamite and other explosives. These operations, which ended in 1993, resulted in asbestos, lead, petroleum and dinitrotoluene (DNT) contamination of soil.

The Agreed Order requires the Port to:

- Monitor groundwater until contamination breaks down naturally (monitored natural attenuation) and decline to levels below state cleanup standards.
- Place an environmental covenant (deed restrictions) on the property to protect people from contamination remaining on site. The covenant will not allow installation of drinking water wells on the property until the contamination levels in groundwater are below state standards.
- Take additional cleanup actions if the contamination spreads or there is a need to speed up cleanup.
