Phase I & Phase II Municipal Stormwater Permit Modifications

The Department of Ecology (Ecology) proposes to issue modifications for the Phase I and the Phase II Eastern and Western Washington Municipal Stormwater General Permits issued on January 17, 2007.

These modifications address the outcomes of appeals from settlement agreements and the Pollution Control Hearings Board (PCHB) orders as they apply to each permit.

You may comment on the draft permit modifications from March 18, 2009, until 5 p.m., May 1, 2009.

Workshops and public hearings

During the public comment period, Ecology will host five workshops and two public hearings.

The workshops provide an informal venue in which Ecology will discuss the proposed permit modifications and answer questions about them. The public hearing is a formal hearing process where the public may provide testimony for the official record. Ecology may not respond to questions or comments during the formal hearing.

Ecology will issue an official *Response to Comments* that addresses written comments and oral testimony some time after the close of the public comment period. If public comments cause substantial changes, Ecology may begin another public notice of draft modifications and comment period.

Proposed Permit Modifications

Ecology modified all three permits for conditions related to compliance with standards; compliance with Total Maximum Daily Load Requirements (water quality cleanup plans); and related changes in general conditions, reporting, definitions, and annual report forms. Ecology also made miscellaneous minor clarifications and corrections to the three permits.

Ecology modified the Phase I Permit conditions for construction and post-construction runoff controls related to manual approval and low-impact development. Ecology added Appendix 10 to the permit to list the Phase I permittee documents approved by Ecology. And, to comply with PCHB orders and settlement agreements, Ecology changed requirements for structural stormwater controls; clarified water cleanup plan requirements in Snohomish County; exempted mitigation sites at the Ports of Tacoma and Seattle from certain requirements; and changed monitoring requirements.

Ecology modified the Western Washington Phase II permit to add reporting requirements on advancing the use of lowimpact development. In the Eastern Washington Phase II permit, Ecology added requirements for the Selah Ditch Total Maximum Daily Load that apply to the City of Selah.

Ecology is also looking for input on options for extending interim deadlines in the permit as well as innovative and costsaving ideas to achieve compliance with the permit at a lower cost. Ecology does not intend to reduce the permit standards, or extend the timelines beyond this permit cycle, which ends February 16, 2012. We are looking for ways to improve performance and reduce costs in light of the economic situation.
