Accreditation of Environmental Laboratories, Chapter 173-50 WAC

The Washington State Department of Ecology (Ecology) is proposing to amend the laboratory accreditation rule under Washington Administrative Code (WAC) 173-50. The proposal will be published in the Washington State Register on April 7, 2010.

The proposed rule is designed to raise fees to cover Ecology's costs for carrying out the state lab accreditation program. The last time Ecology changed its fees was in 2002. In addition, a recent reduction in Ecology staff means Ecology will be changing some of its business practices under the rule.

Ecology has issued a Determination of Nonsignificance (DNS) under the State Environmental Policy Act, a Small Business Economic Impact Statement (SBEIS), and a preliminary cost-benefit analysis. These documents, along with the rule proposal, are available for public review and comment through May 7, 2010.

State drinking water and environmental permits require that accredited labs are used.
