

## Shell Multi-Site Agreement

### What is the Shell Multi-Site Agreement?

Shell Oil Products US (Shell) and the Washington State Department of Ecology (Ecology) formed a ground-breaking partnership to clean up current and former gas stations in King, Snohomish, Skagit and Whatcom Counties. The voluntary agreement currently includes 86 Sites with the potential to add more Sites. The Model Toxic Cleanup Act (MTCA) provides the regulatory framework for these cleanups.

Ecology and Shell signed the agreement in November 2008.

### What are Major Accomplishments and Milestones?

Shell developed an initial time line for cleanup of the 86 Sites in March 2009. This included dates for completion of reports that describe: current conditions at the sites, proposed cleanup actions, and conditions at the site after completion of cleanup actions.

As of May 1, 2010, 12 Sites received a No Further Action (NFA) opinion letter from Ecology. At these Sites, petroleum products such as gasoline, diesel, and oil along with associated by-products were cleaned up to levels defined in MTCA. Table 1 lists the Sites that received NFA opinion letters.
