# Department of Ecology to hold three Reclaimed Water Workshops

The Department of Ecology (Ecology) proposes to adopt rules for reclaimed water use by December 2010. The goal is to develop a Reclaimed Water Program encouraging the use of reclaimed water; assure the health and safety of Washington citizens; protect the environment; and allow us to use our precious water resources wisely.

#### What is included in the draft rule?

- Procedures and responsibilities for regulatory review, permitting and enforcement.
- Technical standards for treatment, storage, distribution, and use of reclaimed water.

#### What are the workshops about?

The workshops begin with an open house to give the public an opportunity to learn more about reclaimed water and the new rule before the agency presentations. At the end of each workshop, the public has an opportunity to ask any additional questions about reclaimed water, its uses, effects on existing water rights, and safety.

#### What is Reclaimed Water?

Water that is used more than one time before it passes back into the natural water cycle. Reclaimed water is sometimes called recycled water because its source is wastewater that is treated to a level that allows its reuse for a beneficial purpose. Reclaimed water is commonly conveyed in purple pipe to keep it distinct from potable (drinking) water.



#### **Advantages of Reclaimed Water**

- Reduces demands on groundwater utilized for drinking.
- Reduces and eliminates wastewater discharges to surface water.
- Postpones the development of costly new sources and supplies of drinking water.
- Can reduce the cost of landscape irrigation when it replaces potable water.
- Can provide aesthetic value within a community.

#### **Common uses for Reclaimed Water**

- Irrigating lawns, common areas and golf courses
- Street sweeping
- Power generator cooling
- Decorative fountains
- Fire hydrants
- Aquifer recharge
- Industrial processes
- Natural system restoration

Reclaimed water cannot be directly used for drinking or cooking.

# **Reclaimed Water and Water Rights**

Under state law, reclaimed water projects are exempt from the state's process to obtain water rights. State law gives the owner of a reclaimed water facility exclusive right to the use of that water. However, those facilities cannot impair existing water rights. "Impairment" is a key concept in Washington water law that protects existing water rights.
