

Ecology Proposes to Remove Site from Hazardous Sites List

The United Parcel Service-Spokane site is located at 1016 North Bradley Road in Spokane Valley, Spokane County, Washington (see Map on page 2). Contractors removed approximately 95 yards of petroleum-contaminated soil from the site. This work was completed under Ecology's Voluntary Cleanup Program. As a result of this completed work, Ecology plans to remove the site from the Hazardous Sites List.

Hazardous Sites List

The Hazardous Sites List is a record of contaminated sites throughout the state that are ranked on a scale of one to five. One represents the greatest potential threat to human health and the environment; five represents the least potential threat. The United Parcel Service-Spokane site ranked a three because of the petroleum contaminated soil at the site.

A site may be removed from the Hazardous Sites List after cleanup work is completed and it meets Ecology's criteria. Ecology proposes to remove this site based upon the following information:

- Review of the cleanup reports.
- Supporting documentation.
- State standards for cleanup of petroleum product in soil have been sufficiently achieved at the site.

No further action is needed at the site.

Investigations and Cleanup

In October 1987 a spill occurred at the UPS-Spokane site while an Underground Storage Tank (UST) was being filled for a test. Gasoline leaked onto the ground, and it was removed and replaced with clean fill material. The area where the spill occurred was then covered with concrete.

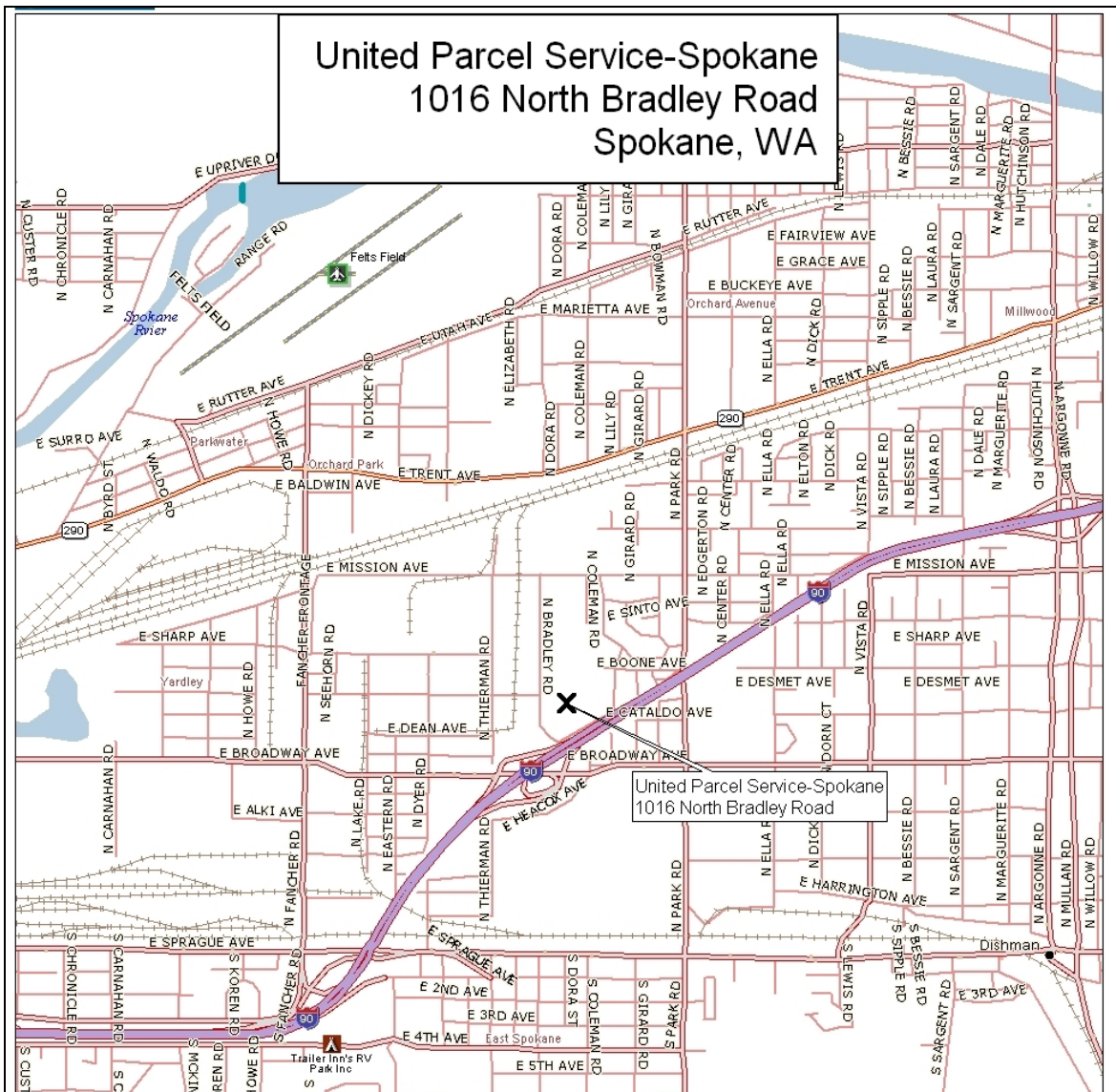
In 1990, five separate USTs were removed. During the removal process at each location, petroleum contaminated soil was found. The contaminated soil was removed and replaced with clean fill material. Including the soil removed in 1987, a total of 95 cubic yards of soil was removed from the site.

Soil sampling was conducted in each area to determine if any contaminants were remaining. Lead was found in the soil but it did not exceed state standards. No petroleum products were detected.

The site remains an active UPS facility and new USTs remain at the locations where tanks were removed.

What Happens Next?

After the 30-day comment period, Ecology will review and respond to the public comments received about the removal of the site from the Hazardous Sites List. If no significant changes are made, the site will be removed from the Hazardous Sites List. The removal will be reflected in the August 2011 edition of the Site Register which is a special edition entitled "Hazardous Sites List."
