# Proposed Grant and Loan Funding for SFY 2012 Water Quality Improvement and Protection Projects

## Ecology seeks public input on the Draft Offer List and Intended Use Plan for state fiscal year 2012

The Washington Department of Ecology (Ecology) proposes to award the next round of funding for projects across the state to help improve and protect the state's surface and ground water.

For fiscal year 2012, Ecology proposes to fund projects using:

- \$15 million in funds from the Centennial Clean Water Program. This program is funded through state bonds.
- \$1.8 million from the Clean Water Act Section 319 Nonpoint Source Fund. This fund is allocated through the federal Environmental Protection Agency (EPA) budget.
- \$87 million from the Washington State Water Pollution Control Revolving Fund. The fund is financed by a federal EPA capitalization grant, state match, and interest and loan repayments.

Ecology requests public input on its funding proposal. You can see the list of projects Ecology proposes to fund in a document called the SFY12 Draft Offer List and Intended Use Plan (Draft List). The list will be online after Feb.18, 2011 at: www.ecy.wa.gov/programs/wq/funding/funding.html
