## **General Regulations for Air Pollution Sources**

The Department of Ecology proposes to adopt amendments to Chapter 173-400 WAC, General Regulations for Air Pollution Sources. The rule proposal will be published in the Washington State Register on June 6, 2012. Ecology is also proposing revisions to the State Implementation Plan (SIP).

## What is the purpose of the rule proposal?

The purpose of this rule proposal is to:

- Amend the rule sections related to permits for industrial and commercial sources of air pollution, including minor new source review and major new source review (Prevention of Significant Deterioration), to make them consistent with Federal Clean Air Act requirements.
- Support Ecology's request for EPA approval of SIP revisions.
- Clarify that the SIP applies to the six air contaminants for which EPA has established National Ambient Air Quality Standards (NAAQS), their pre-cursors, and those air contaminants regulated under Part C Title I of the Federal Clean Air Act.
- Help emitters comply with the rule through better access to references, improved readability, and better understanding of regulations and permitting requirements.

## What is the purpose of the SIP revision?

The purpose of the SIP revision is to meet Federal Clean Air Act requirements, including the requirements of Section 110, Part C and Part D. At this time, the only sections being considered for SIP submittal are WAC 173-400-020 and WAC 173-400-030(3). Ecology plans to submit additional sections of Chapter 173-400 WAC to EPA for SIP approval in the future.

## **Public hearings**

Two consecutive public hearings will be held on June 27, 2012.

During the first hearing, Ecology invites comments on the proposed changes to Chapter 173-400 WAC.

Immediately after the close of the rule proposal hearing, the second hearing will begin. At this hearing, Ecology invites comments on the proposal to submit portions of the rule proposal, (WAC 173-400-020 and 173-400-030(3)) to EPA for inclusion in the SIP. The rule revisions are intended to meet the requirements of Section 110, Part C and Part D, of the Federal Clean Air Act.

## **Comment period**

The comment period ends July 6, 2012.

You may submit written comments on this proposed rule revision and SIP submittal through July 6, 2012. Comments may be presented either orally or in writing at the public hearings.
