

Ecology Proposes to Remove Site from Hazardous Sites List

The Northwest Pipeline Pullman site is located at 2645 South Grand Avenue, Pullman, Whitman County, Washington (see Figure 1). The site is used to house a meter station that regulates and meters distribution of natural gas to local customers.

In 1990 an assessment of the site was conducted and mercury was found in soil outside the meter station. The main source of the contamination was most likely from releases of mercury during maintenance of equipment. The level of mercury in soil exceeded state standards, therefore cleanup was necessary.

Three drums of gravel and soil were removed from under and around the former meter stand. Additional site assessments were conducted in 2008 to further evaluate the extent of contamination in soil. Nearly 49 tons of soil were removed and transported for disposal off-site in 2010. Follow-up sampling indicates all contaminated soil was removed and no further actions are required at this site.

Ecology's Voluntary Cleanup Program provided review of the cleanup actions at the site. As a result of the completed work, Ecology plans to remove the site from the Hazardous Sites List after public comment is received and considered.

Hazardous Sites List

The Hazardous Sites List is a record of contaminated sites throughout the state that are ranked on a scale of one to five. One represents the greatest potential threat to human health and the environment; five represents the least potential threat. The Northwest Pipeline Pullman site ranked a five because of the contaminated soil at the site.

A site may be removed from the Hazardous Sites List after cleanup work is completed and it meets Ecology's criteria. Ecology proposes to remove this site based upon the following information:

What Happens Next?

After the 30-day comment period, Ecology will review and respond to the public comments received about the removal of the site from the Hazardous Sites List. The site will be removed from the Hazardous Sites List if no significant changes are made. The list is published twice per year. The removal will be reflected in the August 2012 edition of the Site Register which is a special edition entitled “Hazardous Sites List.”

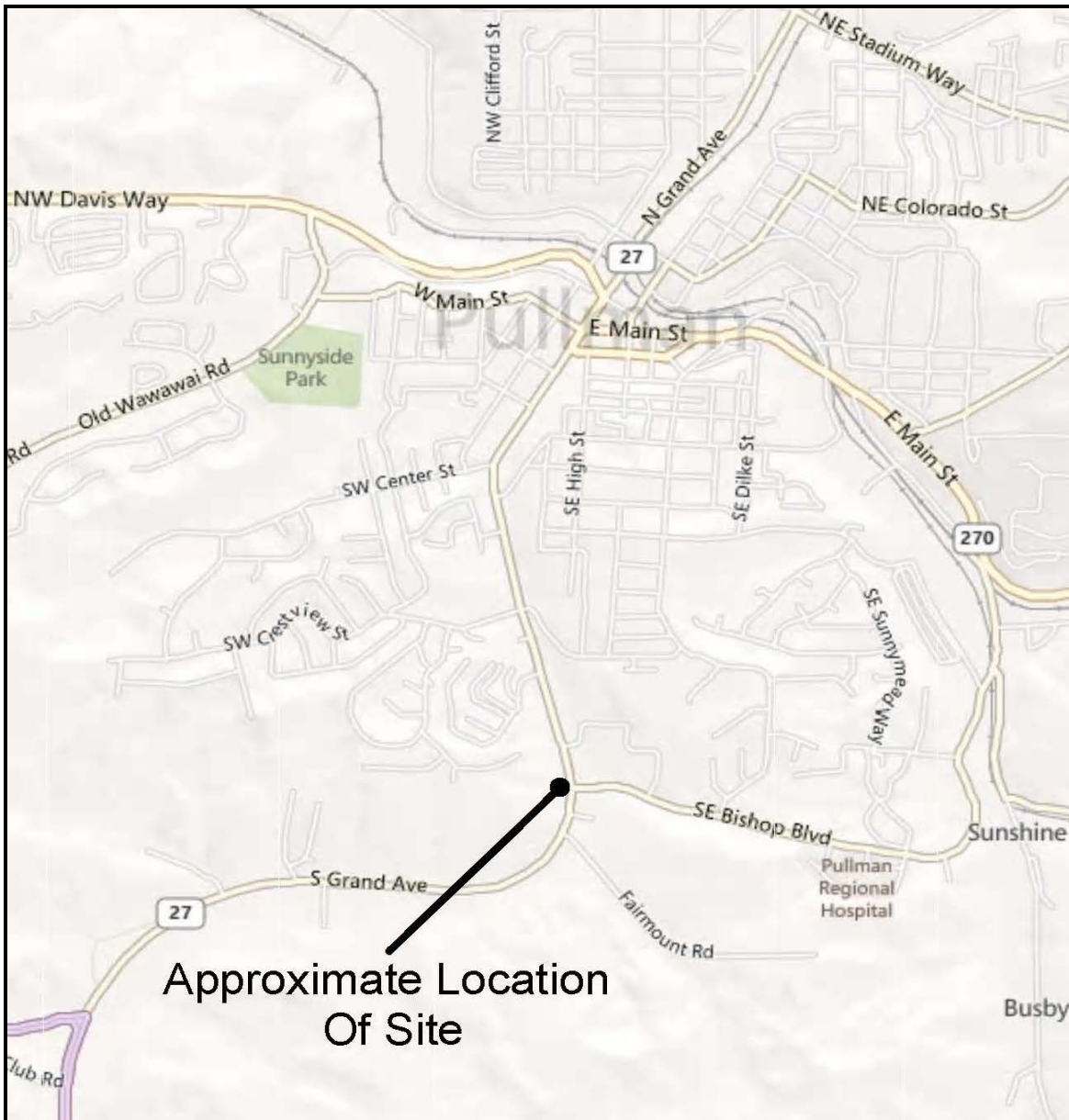
